By the way of introduction, my name is Edward Leszynski. I am the Operations Director of an investigation and protection firm called Special Solutions, Ltd., located in Chicago, IL., operating and licensed since 1994. I have taken the liberty of adding this Addendum to your Client paperwork in order to plainly state the purpose and goals of the investigation you have initiated.

Our standard Electronic Harassment investigation approaches the issue from three different directions, looking for causes in the Environmental, Industrial, and Genuine Targeting categories. In my personal experience, it is within these three categories that results generally fall. ### **Scope of Work**

1) The flat fee cost of \$2400 charged to the client will entail the following services that will be delivered by Special Solutions to the client :

- Arrive at Client Site on the 7th - All Travel, Hotel and Accommodation included in the flat fee of \$2400
