Contract Between Ms. Antony and Ayanna Medina from 3-15-2017 To 3-21-2017

I was hired by Ms. Antony to observe her for a week. I was asked to spend time with her from 9 a.m. to 5.p.m. each day and simply observe her work. She explained to me that she suffers from a mental illness where she can be subject to episodes of involuntary laughter and profanity. She explained to me that over the last year and 4 months when she lived all by herself in this home fighting her divorce proceeding, her episodes were so bad where it could be as often as every 3 min while she was alone in the house. She also explained to me that for some reason those involuntary episodes don't seem to come on in someones presence even though she is performing the same work function while she is in someone's presence or when she is alone. She has 5 months of recordings on herself to prove that. She hired me for a week as she wanted to see what her demeanor would be in someone's presence with a tenure as long as a week where she worked for every min of those 8 hrs each day for those 5 days performing the same work function as she does when she is alone.

I was asked to prepare a report of the observations I noted each day and also to attest the video recordings I saw on the external drives she had amassed over the last 5 months.

drowsy while leaving a message.

4:10pm: Still working and on the phone.

5:00pm Leave.

8:50am: Leave for doc app.

9:15am: Filling out medical paper work.

9:30am: Waiting.

10:24am: Done with app. Leave clinic.

10:45am: Arrive at the house. Washed dishes.

Smeeta Antony is a very friendly and intelligent individual. Since meeting Smeeta on Tuesday March 14, 2017 she has not shown any episodes but behaves in a professional manner, although I believe in the genuineness of her conditions. She is very committed and determined in her work. She did not have any psychotic episodes or shout profanity while working, cleaning or watching recordings of herself.

The dates below reflect the cataloged and the uncataloged videos that I saw on Ms. Antony's external drives that contains video recordings of herself that she has recorded on herself for 5 months or more. These dates reflect everything that she has cataloged till date by going back and watching these videos so she knows what she has experienced in every one of these episodes. She states that she has no recall of what she states during her episodes. While she might be aware some of the fact the she laughed or she screamed or she was profane she does not know what she stated unless she goes back and watches these videos and puts in the effort to write down what has flowed out of her mouth. Cataloging these videos take a lot of time and effort. The dates below also reflect everything that is not cataloged till date. From what she has watched till date she feels like it is the same garbage or variations of the same garbage that has flowed out of her mouth.
