Dear Chief Tate.

I would like to Thank You for taking the time to meet with me on 7-11-2016 to answer my questions and also for the CD that was prepared.

On hearing the CD I have more questions that hopefully does not infringe on your time too much.

As a layman it is common misconception to look 911 for their protection. It is thru their experiences that they learn what is civil, criminal and what elements of the crime need to be established for action to be taken:

On grounds of what has transpired these last 6 years I so would appreciate you taking the time to answer the listed below. Your responses would help me immensely work toward my responses to the allegations I am alleged with:

- 1. When a person feels stalked and feels like devices or other stalking systems might be pointed at her making her feel a certain way, what elements of crime if any would you look for to aid the victim? What guidelines if any as published by the United States Department of Justice are followed in these cases? If there are other guidelines followed in cases such as these, I so would appreciate you stating what those might be?
- 2. In cases of Domestic Violence, after listening to the CD my understanding is that you would direct those victims to Southern Valley Alliance for Battered Women. In cases of Stalking where technology might be used, would there be an agency that a victim might be directed to so that she might be better educated on what can be done to build her case?
- 3. In cases where an individual is a grave threat to herself, her family and others in the community as I am alleged to be, would you be open to initiating processes to put me, my home and car under surveillance as requested in my letter 4/23/2016. If it is out of the bounds of your jurisdiction and is a civil matter who would you direct such requests to?
