Hey Dad & Mom,

As per my response to your email dated Feb 20th asking for me to come down to India to be observed for 2-3 months so that doctors in India are able to prescribe medication, I asked for you to think about a couple of things that are very necessary for my upcoming committal:

- I need your statement and Mom's statement Please refer to my email
 in response to your email on Feb 20th. This letter was written prior to
 my response to your email on the night of Feb26th so please refer to
 my response to that email with regard to any clarification on what I
 need in that statement.
- You also indicated that u are not in a position to fly. It is very important to me that in your absence and inability to fly, that you have Shai and Shom be in a position to fly since they are both in good health and have 4 houses and enough money available to them. I am sure they can spare the finances to render the necessary support.

Enclosed in the packet is a weekend filled with nonstop psychosis around the girls where I do not have the ability to stop the psychotic chatter and profanity flowing out of my mouth continuously.

This weekend is after a 4-day course that I spent all day at a Project Management Institute trying to get certified in Project Management. During these 4 days, there are no episodes in the institute. Life at home after I get back from a long day at class is exactly like what u see in these videos.

It is very important to figure why I do not have the ability to have any kind of control while I am on the inside of the home. As always on the inside of the home, I am screaming and laughing continuously nonstop and yet I have the ability to do me and function normally on the outside of the home. While u may be trying to locate doctors in India, I need a facility with very sophisticated monitoring systems that can monitor my brain wave electrical activity continually under the camera so that they can actually record the activity and see the video simultaneously when an episode comes on.

I also need a sophisticated facility that has doctors that have researched the brain neural chemistry especially as it pertains to psychosis and Schizophrenia using sophisticated imaging systems. The United States like the National Institute of Mental Health and the Mind Research Network in New Mexico has very sophisticated EEG headgear, and imaging systems such as an FMRI that will actually watch and monitor the areas of the brain that fire in correspondence to a function.

In my case, episodes come on when I am typing at my keyboard, when I am trying to read an article, when I am trying to mop the floor, when I am trying to do dishes, when I am doing laundry, when I am cleaning around the house... Etc. They are all functions that my brain is performing. At any one of these functions that my brain is performing, my brain fires into the episodes that u see on these videos. I need a facility that can actually observe me and monitor me while I am performing one of these functions. While they may not be able to observe me and monitor me while I am cleaning around the house, they can certainly observe me and monitor me attached to equipment in their facility while I am typing at a keyboard or reading and watch my brain as it experiences an episode. It is very important to understand what the difference might be in the frequency of the episodes that I might experience within a facility versus what I might experience at home. It is also very important to understand how a brain like me is able to exercise any kind of control.

Minnesota does not have the kind of equipment needed to monitor me and study me for extended periods of time other than a couple of clinics that might monitor me for a day or so which I will continue to pursue. I need research programs that have studied brains like mine for years and have all the equipment available to them that can image and study brains like mine. The first response step in Minnesota will be simply to medicate me and not try to understand why my brain died the day after a surgery to such a degree where I am constantly under attack while I am in the home but I can still function and speak and write intelligently while I am out of the home. What makes u think that something bad did not happen to me after that surgery? Why would I get stolen of every cent, and why would I get abused to the degree I am if something bad did not happen to me. If it is sheer paranoia, inspite of everything that has occurred/transpired and inspite of all the research available on how broken the neural chemistry of a schizophrenic brain is, then there is only one way to answer those questions. I need resources to have me monitored under sophisticated equipment that can answer those questions that I do not have and that between You and Shailesh - you can easily pool in.

It is also important that Shailesh fly in and live with me and simply observe me while we turn on cameras in the home so that he can go back to those recordings and watch me live those episodes. We can also drive to certain areas within the twin cities where I am very certain that episodes will not come on. There might also be a difference in the amount of episodes that occur in someone's presence. If that is the case the length of the number of days that passes by without as many episodes while I am performing the same functions is also crucial to research facilities to figure out why I am under attack to the extent I am when I am alone by myself. What causes it to happen? This analysis will also be very important to any future committals especially as arguments that needs to be presented in my defense.

You believe that unhappy memories within the home brings it on. It is very important that u have the ability to ask that question to psychiatrists that study the chemistry of an ill brain to the extent mine is and get an answer as to why that

would make any sense when a woman has done nothing but focus on what she needs to be working on every minute of her life.

What u are referring to can happen as a result of a person being re-exposed to the same triggers or the same situations that brings on the episode or if her brain is bringing on episodes as a result of certain content that she is reading causing her to relive certain memories. If that is the case, that is a brain that still does not have any control over what she is experiencing in that moment unless she is intentionally putting herself there experiencing flashbacks. If that is the case, she is a healthy brain, which should mean that she should be able to regulate out which I don't have any ability to do. When I don't have any ability to regulate out, why can I attend meetings with so many folks and put myself thru the hell I have put myself thru without any episodes coming on at those places. So what is wrong with me?

There are also other experts available across the United States that might be able to offer expert opinions after studying my videos that will require money resources to be spent.

I am not experiencing moments of irritability, or moments of agitation or moments of depression or moments of visual hallucinations or moments of command hallicunations causing me to exhibit bizzare behavior. How can that kind of brain have any kind of control on the outside? Coming down to India does not solve the issue. It is your observations of me in this home, in comparison to the recordings of the sheer hell I have lived that is recorded over a span of 5 months that is crucial to the case and my defense in addition to your statements of your observations from 2011, 2012 and 2014. It is not only my innocent life but also 2 other innocent lives that got murdered within this system.
