Bottom line u do not seem to exhibit the interest needed TO WITNESS the murder that is going on inside of the home when I am alone and under attack every 3 min.

Bottom line your presence in this household could make a difference to know if the attacks in this household come down.

You seem to have no interest in knowing what brought it on after a surgery nor do u seem to have any interest witnessing the murder in the home.

The 4 homes are your assets WITHIN A FAMILY THAT YOU ENSURED TO FLY IN WHEN I DID NOT ASK FOR IT IN 2011,2012, AND 2014, which amount 1/2 a million dollars each at the very minimum. You seem to not want to want to sell any of those assets and ensure that the finest care is given to me in the finest centers to figure out the murder I have lived in this home.

It surprises me that after u have watched the videos and trauma I live every 3 min in the household that it does not even incent u to want to know what your personal observations of me under attack in the household will be.

You ensured of your presence in this household in 2011, 2012 and 2014 and ensured that I took medication without even thinking about it.

You ensured that u did not think twice about the emotional and physical abuse or the large amount of jewelry that was stolen from this home and ensured of your silence in the system.

That said there should be no reason to call.

What is truly important are your explicit statements on the record that has been repeatedly asked for about the following:

- 1. Your statement on the observations u witnessed in 2011, 2012 and 2014
- 2. Your statement on what was stated to Heidi Schultz and my psychiatrist in 2012
- 3. Your statement on the observations that u see in these videos
- 4. Your statement that u do not have the resources or the bandwidth to take care of the murder in this household even though as a family you have 4 spare homes and even though u are well aware that I am living on a \$1000 support and everything stolen
- 5. Your statement that at this time it is not convenient to you or Shom and Shailesh to fly in and witness the murder in this household that I have lived for the last year and 4 months inspite of receiving 3 flash drives filled with videos of psychosis that show you what I go thru.

YOU SIMPLY HAVE TO STATE, I CERTAINLY CANNOT FLY IN TO WITNESS IT NOR DO I FEEL COMFORTABLE AKING THE REST OF MY FAMILY TO WITNESS IT. THEY WERE PROVIDED WITH THE SAME INFORMATION. IF THEY WANT TO WITNESS IT THEY SHOULD FEEL FREE TO FLY IN

Hi Moal,

Please go through once again my mail of 27/02/2017, wherein I made very clear about my present financial constraints and still then effort is in progress to organize atleast \$ 3000.

Your mail dated 04/03/2017 (8.30am)

We are really happy to note that you are visiting a psychiatrist, but cannot understand as to why you do not like medication. It is for the qualified Doctors to decide whether you need medication and if they really feel it is a must for you to undertake appropriate medication, you should accept

the same for your good future. When you had medication in the same hospital earlier and continued till certain period at home. You were very comfortable in all respects even to the extent of being able to work for 6 (six) months, but discontinued the medicine, under the pretest everything is alright and your illness reappeared which resulted in loss of the job and other problems followed. Moal, practically everybody in this world may have some illness, but gets treated by qualified Doctors. When we go to a Doctor, we will only explain the problems and he / she will decide the type of medication called for. We are not qualified to dictate the type of treatment, medicines etc. our request to you to please undergo the type of treatment advocated by the qualified and experienced medical practitioner until advised otherwise. We should have trust in them.

We fail to understand as to why you would like to bring in lawyers to take care of a research program for your illness, we believe it is solely the job of medical professionals.

It is mentioned that we and Shai together have 4 spare homes. Please be clear, as we requested through the last para of our letter of 27/02/2017 that <u>you better talk or send mail to Shai / Shom</u> directly as we have No influence on them.

With regards to our situation, we have a home in Stone Arch building which needs repairs / painting since last two years, but could not undertake due to financial reasons. Mom's Poona home has a mortgage on it plus what money she invested was a long investment plan against tax clause which provided tax exemption on invested amount. Disposal of same will come in for normal tax plus heavy tax PENALTY for charges that the tax plan was orchestrated for tax evasion plus the very small complex is not complete. So sale prior to that will not be possible for both Tax and Municipal Law reasons – further under these circumstances sale proceeds will be very low and lost totally in tax penalty.

You mentioned towards the end of the letter under reference that you need someone to observe you at home with camera turned on so that more evidence alongwith his presence OR someone else in the family can be presented. You have already done such long exercise through certain professionals by payment of about \$ 4200 and we are confused about such study again. However, you have already marked copy to Shai and hope direct contact.

We confirm having received the parcel regarding "Order for Judgement and Judgement and Decree" just now and shall revert after thorough study of the same.
