Request to be Observed Inpatient

As per our conversation on 12-19-2016, I demoed a couple videos to you showing me laughing hysterically at my desk for prolonged periods of time and screaming profanity at my desk for prolonged periods of time. We talked about the fact, that I have prevailed this year under attack by simply staying at my desk and continuing to work while ensuring of a

presence outside of the home that can attest to normal behavior. We also discussed the behavior clearly seen in all videos that show me breaking into euphoric or profane states and having the ability to go back to work at my desk and stay at work till the next involuntary movement fires.

I asked to be observed inpatient so you can see the difference between who I am on the videos and who I am while in unit or as inpatient as no hospital ever picks up what I live at home. At that time, you said that you did not need to as you believed me.

You were also of the opinion that if I felt that way that it was a Police problem and not a medical problem while not being able to provide any answers on my diagnosis from 2012.

While u implied that you have seen Paranoid Schizophrenics hold down a job in the community and live a normal life you were not able to cite a single case like mine where my brain was exploding in the house every 3 – 5 min at my desk that involuntarily, be that abnormal on the inside of the home and that normal on the outside of the home.

I think you were comfortable stating that you had not seen such a case in your experience nor were you able dredge up such a case in medical literature.

It was also your opinion that the day I spent at Mayo Clinic, doing a MRI, a brain EEG that was event based – which in my opinion I think you meant that the graph would read differently if an event was taking place in my brain, and blood tests that looked for markers that could be secondary causes of psychosis concluded the level of testing that you could offer. In light of the fact that it was all normal, there was no more you could offer other than prescribe me a round of antipsychotics with no explanation for why a brain that fires this involuntarily every 3-4 min at home can spend a half day in court or an entire day in court and never fire involuntarily.

However, while you are not able to provide me with a week of inpatient observations that could provide a clearer picture to any investigation, you stated that you wanted to chat with Neurology to see if any other diagnostic testing could be made available to me in terms of inflammatory marker detections that could hopefully lend itself to any neurologic diagnosis.

I have not heard back from you as yet. Since I met you, I hired a private investigator to surveil me at home for 2 days to see if my attacks in the home would present differently if someone was with me inside of the home.

It did. While the private investigator was in the home, I had 2 light episodes of chatter and laughter at my desk and did not experience the violent hysterical attacks that I am under otherwise. I did however experience them before and after the Private Investigator arrived and left.

I shared with him about 8 videos of what I go thru at home from the 4 ½ months of recordings that I have on myself along with all the evidences of the victimization that I had endured.

lam sending you those 8 videos and hoping that you will re-consider observing me for a week. In 2012, and 2014 it took nothing but a statement from my husband to institutionalize me for an entire month along with 9 months of neuroleptics that wrecked my life for good as I got rendered a paranoid schizophrenic realizing the motive that any abuser intends which is that I would never have the ability to be anything but a paranoid schizophrenic with as much credibility that a paranoid schizophrenic could offer for the rest of my life.

Today, I repeatedly ask doctors to observe me for a week bring them that much evidence of the hell I live thru asking them to save my life and I get nothing but doors shut in my face. I wonder why?

I truly hope you will see what a week of observations will enable save my life so that I can present a stronger case to law enforcement. I truly hope you will re-consider and save my life.

I also did some research on some neurologic disorders and ran into PBA which is a neurologic condition that causes a brain to fire involuntarily causing a patient to experience bouts of crying, bouts of euphoric laughter or bouts of agitation for no rhyme or reason. Any trigger can set it off and it is a brain that has no control over itself.

Most Cases of Schizophrenia, hear voices and loose their trail of thought due to the voice insertion in their head as they might be responding to the instruction they receive in their head as oppose to responding to the question u asked. These cases certainly do present itself as extreme agitation, extreme rage, and very dysregulated minds causing them to withdraw from everyone however I don't think cases of Paranoid Schizophrenia presents itself where the content just flows out of their mouth as sheer gibberish or content from their past all wrecked

and garbled out of their control every 3-5 min unless medical science

can educate me otherwise so that I can better understand my condition.

The very fact that the content that is flowing out of the mouth is very

wrecked and garbled is a strong indicator of how wrecked my brain map

is. Why am I able to go back to a normal brain map resuming work back

again at my desk after experiencing such wreckage after I just got done

spewing such gibberish so consistently for 6 years straight?

I am also attaching 2 hrs worth of videos of me taken on 12-29-2016

taken the day after the 2-day Private Investigator Surveillance, in St.

Francis ER in Burnsville cataloging my videos that I took on Day 2 of

Private Investigator Surveillance showing that no episodes came on in

spite of being under attack continually at home.
