HI! Heidi,

Embedded within this packet is an external flash drive that documents video recordings of my life at home.

Once you watch these videos, You might want to ask yourself the same question I have been asking the system for 6 ½ years which is – How is a woman this volatile at home, exhibiting the extreme profanity, the prolonged periods of euphoric hysterical laughter and the response she exhibits to the command hallucinations to the degree she is, be this calm on the outside of the home?

On these videos, you see a woman trying really hard to work at her desk. Out of nowhere, <u>profanity flows out of her mouth</u>, <u>she breaks into hysterical laughter</u> while she is working, <u>she whips around and begins to scream profanely</u> with her hands waving in the air <u>talking to someone in the environment</u>.

When you watch these videos a few rare and unexplainable things come to mind:

 After she is done experiencing that involuntary action she has the ability to go back to work at her desk and stay working till the next involuntary action fires like the prior action did not occur.

- The Chatter can be non-stop. If you watch her trying to work at her desk for just a day in her life, you will see she probably spends probably three quarters of her time in chatter, hysteria and a profane phase while she is struggling to return to herself to work at her desk. Recordings 11 -22 Authoring Closing Arguments and Psychosis at Home Attached 48 files" found under the folder Hell I went thru authoring Closing Arguments is a good example of the hell I live. Please watch the videos with the Pink hue.
- She has the ability to speak on her cell phone with no involuntary
  actions firing inspite of it firing <u>continually</u> while she is working at
  her desk. She <u>makes these calls at her desk</u> and still <u>does not</u>
  experience her brain firing involuntarily.
- She looks like she is a possessed demon in these videos.

For 5 years of such acute illness from 2010 to 2015, not one 3<sup>rd</sup> party observer has seen me display this kind of behavior in public. I am an absolute out of control insane demon in these videos. How could I possibly transition to the calm state that I exhibit, and how could I possibly exhibit the self-control regardless of what I got put thru for 6 ½ years straight, if I was not being attacked on the inside of the home?

My parents, sister and brother-in-law visited me in 2011, 2012 and 2014. They were here in this household living with me for 2-3 months in 2011,

2-3 months in 2012 and 2-3 months in 2014. Why would that kind of emotional display not even remotely bother them? This is not a woman who is just agitated as a result of stressors in her life. This is a woman who is laughing uncontrollably and exhibiting responses to command hallucination's causing me to scream, be profane, be hysterical beyond control, trash objects around and hit myself. How can these episodes not be brought on as anything but a response to the hallucination's I experience? If so why do I not respond to those hallucination's on the outside for 6 ½ years straight? Can there be a stronger case for what I believe was done to me on that surgery table in 2010? In these videos, I exhibit a case of chatter schizophrenia where I am blind spewing profanity or anything I may have read in the past. Are they that naïve, for the intelligent globe-trotting exposure that they have to not recognize what was done to me. My parents and sister were in your office in 2012 advocating for the domestic abuse that I endured. Am I that paranoid, when I question something as simple as why would a family who sees me respond to command hallucinations to the degree they do, sees me spew profanity so uncontrollably, see me laugh so uncontrollably for prolonged periods of time not recognize how involuntary those brain reactions are and how impossible it is to exercise any kind of selfcontrol. Why am I able to exercise self-control on the outside?

They have watched me have face time at all classes for an hr straight, in  $3^{rd}$  party instructor presence around my kids and other parents as they chose to accompany me on the outside, to those classes or grocery

shopping, go out on vacations with me or just simply go out with me, watch me entertain for large groups on the inside of the home or accompany me to other social gatherings.

How does my family explain the behavior they see on the inside of the home vs the outside of the home? How does my family explain the ability to exercise control at all the social gatherings that I was part of with them when I am responding to hallucination's to the degree I am? How does my family explain the sudden explosive onset of the symptoms that I experienced the day after my surgery in 2010? How does my family explain the split personality that I have lived for 6 ½ years assuming they get it? I am demon taking on a form on the inside of the home. Yet, when I step outside of this home I am a calm woman after I just got done exercising a demon in the home. For lack of a better term that medical science can provide me with I call it a split personality one where I am highly volatile inside of the home and one where I am calm outside of the home. I have lived a personality for the inside of the home and one for the outside for 6 ½ years. It is a medically impossible phenomenon in the world of chronic psychosis and Schizophrenia. How does such an educated family explain their ignorance and their need to ignore the situation especially when they fly in to take care of me and express such love and concern as they did in 2012 -the year of my committal? What steps if any have they exercised to understand schizophrenia assuming that they were that ignorant, or even try to use their very rich money to free me from the arms of a filthy abuser,

assuming that was the true intent behind their presence in Minneapolis in 2011, 2012 and 2014? How does my family explain me stolen of every cent in 2013? Is my family that naïve when they do not recognize motive and that something is VERY WRONG with the picture. How does my family not recognize what financial takeover is when I was left out the equation on all fronts in the household, where I had no insight into any decisions in the household? My parents while advocating domestic abuse in your office, did not have any qualms encouraging the abuse while in the household. What measures if any were taken by them to ensure that I return to an independent state of my life, the kind of woman that I was before 2010 especially when they raised me in private schools and chauffer driven cars? If they DENY seeing me in such a state INSIDE OF THE HOUSE, what were they attesting to when they were here talking to case workers and what made them want to put themselves in charge of a mental health situation that they had no insight into in 2012? My father's precise words while it broke his heart to exercise such parental tough love was "If there is a problem, it needs to be solved. It is good for you to be on medication." What should that attest to? That MY FATHER did see me that demonic while he was here in 2011 or that he would believe my soon to be ex-husband's words blind. If he did see me that demonic in the house in 2011 and that normal on the outside in 2011 over a span of a 2-3 month stay, why did that not bother him? What kind of man is he?

Can you in all honesty as a very normal reasoned mind see how impossible the notion is that they did not know what transpired on an innocent surgery table in 2010 - where they reject the thought of what I believe, when I state that "I was setup by them and my husband to be implanted with some sort of nano-implant on that surgery table in 2010"?

I am very aware for a paranoid delusional schizophrenic mind that the very notion that I believe that I was implanted with some sort of nano device in 2010 during my breast lumpectomy is a key symptom of schizophrenic paranoid mind.

However, for a phenomenon this rare, over a tenure of 6 ½ years, where I rapid cycle between such intense states of extreme agitation, uncontrollable demonic laughter, talking to imaginary friends, slapping myself, trashing objects which comes on only INSIDE OF THE HOME, I cannot provide any other explanation unless the medical community can. When you put this rare scientific phenomenon in the context of everything stolen, everything taken over by the husband to ensure his mentally ill wife is affected, no attorney representation, a family who encourages abuse by ignoring it and not asking the questions they should be asking, the physical and emotional abuse I have endured, the blind eye that my parents have turned towards the abuse, a very lengthy divorce proceeding ensuring that I have no say in my children's

<u>lives shortly after 2 episodes in the community</u> – Why does it not reek motive?

I can provide numerous contacts and references and concrete evidence in form of my credit cards alone that prove that I am on the outside of the home on a daily basis. The absence of intake reports alone till the 2 intake reports in 2015 is evidence alone of the fact that I do not exhibit that kind of demonic behavior on the outside. Yet, every individual in the system will ignore such a simple fact and state it as lack of insight and that I am argumentative as a result of my illness when not one individual can provide an explanation for why there are no observations on the outside? Why should I not see it as motive when after 5 years of not experiencing any episodes on the outside of the home, I magically out of the blue experience 2 explosive episodes – 5 years into my illness which is shortly followed by an exparte proceeding necessitating my removal from their lives. Why does that not reek motive? Can u see what an advantage it is to be declared a paranoid Schizophrenic as I have to think long and hard before I question motive. Can u see how easy it is to bank on my silence and my inability to go up against a system that is pre-conditioned towards a paranoid schizophrenic?

Thankfully for me, I ensured I lived my live every day in the community, wrote my statements and walked away from it. To this day I bank on my log i.e. my life in the community on a daily basis as there is not a

medical explanation till date that can prove the hell I have lived or the lack of explanation for the need to not report/call the episodes in, assuming that folks have seen me this explosive in the community prior to 2015 especially around children.

The contacts and references provided at the end of this letter will attest to seeing me in court for a half a day in court while I went thru such demonic hell on the inside of the house. The videos on the external hard drive are recordings for the month of September screaming and laughing demonically while I was on the inside of the house trying to fight the divorce proceeding in every way I could. I am sure any human being can see that there is no way in hell that I can step into a court house for a ½ a day with no episodes coming on, when I am such a demon inside of the home. That's the kind of human experimentation program, my innocent life was entered into. Should I feel loved and supported by such a family and husband?

Please watch the videos "Recordings 11 -22 - Authoring Closing Arguments and Psychosis at Home Attached - 48 files" found under the folder Hell I went thru authoring Closing Arguments. Please watch videos that have a Pink hue and you will see the continual laughter and demonic profane abuse I endure as I stay working thru it all inside of the home.

What kind of a family do I hail from assuming that even got what they walked my innocent life and my 2 innocent children's lives into?

Would I be paranoid to question why a man who lived in grave threat of his life for 6 ½ years straight, would want to live with me for 6 ½ years since 2010? Why would a father who was so responsible and loving not take care of his innocent girls and ensure that I not have anything to do with them prior? If this is the kind of mother that lived in the home with the children why would he even encourage it? Why would he want them to be exposed to me for 6 years straight? If it was his support for me, where was the support when attorney representation was denied, when I was stolen of every cent, when he deliberately ensured I would get paid out at his will and ensured I have no insight into even what he earned, why refuse to train dogs where I am the maid of the house cleaning after them, why let maids go? Is that not emotional abuse intended to affect me? How did that amount as support? Why ensure that everything I instilled in them got canned even before temporary order was ruled? Was that intent to affect me? How prepared was he to ensure that all decisions would go into effect immediately after he served me the divorce proceeding? Would I be paranoid to assume that he banked on a court appointed investigation that banks on mental health records and the girl's ability to make a statement that would count in court once they are of a certain age? Why not appoint a private investigator who would offer video surveillance and offer proof of my demonic behavior to the courts or to a psychiatrist

to comprehend what is wrong with his wife? Why would he not want to offer videos to a psychiatrist and question the split personality behavior especially in light of how much was stolen from the home if he is so naïve where he is just not able to comprehend Schizophrenia? Why would even thought that someone is trying to hurt her not even remotely cross his mind? Is he so naïve that he is just not able to comprehend the split personality I have lived? If he so naïve what kind of support has he rendered to his mentally ill wife besides taking over every decision in the household and ensuring that she was the maid of the household?

I have spent months studying schizophrenia and put myself thru every diagnostic testing that I could avail of on any research program I could get into as no member in the medical community could offer me any testing, while fighting the divorce proceeding. Thru my stay in these research programs, I shared these videos and asked for opinions as to whether they have seen a schizophrenic demon like what they saw in the videos for which I received no answer. Why aren't there any reactions? Why is the medical community not horrified?

Research Program, that studied the alpha 7 nicotinne receptor binding in the brain of Schizophrenics. The program involved me taking blood tests, urine tests, cognitive testing, MRI, a PET scan and a spinal tap to study the inflammatory markers in the brain. It was a 2-day study

program. Inspite of being a paranoid schizophrenic, that freaks at even the sight of a cell phone as per my husband's testimony in court, as many needles over a 2 day study did not bring on any episodes. The videos were shared with the principal coordinator of the program Dr. Coughlin.

Lattended a similar study in the University of Minnesota who performs cognitive testing, over a span of 3 days via a 2-3 hr interview and computerized testing studying the cognition of Schizophrenics. Lahared the videos with the principal psychiatrist Dr. Agnus McDonald (612-626-8663) and got nothing but stoic reactions from watching the horror of the videos as he did not necessarily want to share an opinion. Do you think he would feel obliged to fulfill his good citizen responsibility where he would feel the need to notify appropriate authorities like otherwise concerned individuals around me do, like my neighbors in the neighborhood or concerned drivers on freeways or concerned parents calling intake reports.

It seems strange that there are no intake reports between 2010 and 2015 calling in my demonic delusional behavior in the community where I am exhibiting profanity, hysteria or the need to respond internal stimuli when the typical behavior is for people to be quick to call in reporting unusual behavior.

I also flew into New York and hand delivered the videos of recording on me and my story to the NBC mail center to see if I would receive a response and received a call from someone living in New York stating that the flash drive was trashed in his yard. He wondered if I would like to have it back and was sorry for what I was going thru? Do you think a journalist would deliver it to someone's yard or a delivery boy that I hand delivered it to would be interested enough to trash it into someone's yard. Why are there no reactions? Anything and everything horrifies the media – Does it not? Why aren't there any to see a woman this lunatic?

I also sent a letter to Randy McAllister who is a detective sergeant in the Twin Cities Area and a principal at Minnesota Threat Professionals – an agency used by court systems to assess the level of threat a victim experiences in criminal cases. They have partnered with the legal system and testified in many cases.

He is a detective sergeant. I received absolute silence from him. Why is he or anyone at his agency not horrified after seeing this videos. I am also attaching a copy of the letter that I sent to Randy McAllister explaining the program I have lived. How does my letter not co-relate to the videos showing the hell I have lived for 6 /12 years. Do people want to help now? Do the people who have seen the hell first hand want to call it in now?

I also met with a neurologist, thru Park Nicollet (Dr. Worley) who offered me a 24 hr Brain EEG. The videos for 8-30 and 8-31 on the external flash drive will show me wearing the EEG Gear to an Apple store in Edina having normal conversations while I was in the store trying to fix my ipad. I get home, I am still wearing the headgear trying to get to some of the recordings and all hell breaks loose. I am screaming profanity and am under heavy attack. The EEG results however pick up nothing. The reports from the nuerologist office show that the readings are absolutely normal. Why?

You may ask as to why I did not share the video recordings with the neurologist. My entire life went thru hell and was amplified every step of the way because the system refused to examine statements and ask simple questions. A simple question as to how medically feasible is to have no observations in the community when she lives her life out there daily is more than enough to see something is amiss. When you paint that in the light of the abuse and the fact that she has nothing left the picture is as clear as night and day. Since the system refused to ask those questions, I have very insistently asked those questions as it was important for me to see what answers the medical community had on statements alone since it was so good at rendering a diagnosis on the grounds of statements alone without any questions.

Today, I bring you the recordings as well as your ability to offer me extended diagnostic testing where you can ensure of YOUR ABILITY via DHS provided services to observe me in home and observe for yourself as to the hell I go thru.

I am also attaching a letter that I sent out to my parents with proof of a Fedex receipt proving that I sent them a letter and the videos of the hell I go thru on a daily basis. I would love to see the intense need that they might experience to protect their daughter's life causing for them to fly in on an emergency basis rushing me into the care of a specialist or a private investigator - so that can get to the bottom of the truth ASAP.

I also sent a similar letter and a copy of an external drive to my loving sister and brother-in-law that was in your office advocating their love for me. I would like to see family have the balls to extend their love today in the light of what they see. I am sure you know what I mean. I have enclosed the letter I sent out to them as well.

The external drive also contains a copy of the Police Reports, videos of the needless attention that I have received from Law Enforcement especially over the last year showing them tailing me needlessly, a copy of the Exparte Order and the sworn affidavit my husband attested to when initiating the divorce proceeding and a copy of my mental health

trying to work from home. It is important to note that after I am done screaming and laughing hysterically that I seem to have the ability to speak normally on these cell phone recordings and seem to have the ability to comprehend normally. I am just done experiencing an episode. Why does another episode not come on while I am on call?

This Drive also contains continual hijacks of my computer and how files and recordings are deleted off my computer continually. You have proof of the cell phone recordings but very often you will see videos deleted in the sequence that show me screaming and getting on a call that calm. Those videos tend to be deleted especially after I call it out in my letters. You will also see camera lighting altered, you will see neuronal chemistry altered in these videos. You will see the date and time on these videos continually reset. You will also see the clarity of the videos altered. Nevertheless, once dates of cell phone recordings are corelated to the video captures, I am sure you can make good guesses on whether I jumped on the call during one of these explosive episodes at home. I have bought about 3-4 cameras till date trying to keep these recordings alive.

I am also sending a copy of these videos to the county attorney's office and to Law Enforcement. I asked for them to put my home and video under surveillance months ago. I begged for every agency to open

an investigation months ago. I got back responses from every agency asking for me to stay it in the context of the divorce proceeding and that they refuse to open an investigation. The divorce proceeding was extended out to an entire year. For an entire year, I have had no choices but to wait my turn and put myself thru this much courtesy the refusal from every agency.

It was as simple as Law Enforcement with its equipment monitoring me for a week and the picture would have fell in place. **That's what my life** has been thru courtesy the gross negligence of the system.

Months ago, if they had listened they could have saved my life. I have put myself thru that much and built a log in the community thru this year as the system ensured I had very minimal access to my old everyday life when they ensured I had no access to the kids. I have knocked at every psychiatrist's door that I could get on the calendar for asking a question that you should have asked for me. Can a woman exhibiting as many paranoid schizophrenic symptoms especially one that has a need to act out on her delusions either verbally or physically to the extent she does as stated in Dr. Grazer's report in 2012 **not** have a need to act out on her delusions either physically or verbally on the outside of the home.

On this drive, you should also see a call showing you proof of the fact that I am exposed to radiation.

It would be pointless telling you that I have electricity or something else running thru me constantly as I would have no way of measuring what is running thru me inspite of continual efforts to keep devices up and running. It just gets portrayed out even more as a Schizophrenic's mind if I choose to tell you what I live on the inside of me without proof of it. So, I asked for the medical community to run continual diagnostic tests on me if they are so convinced that I am a paranoid Schizophrenic and not a woman being continually attacked in her home especially in the absence of intake reports in the community inspite of living a daily life in the community.

I am also enlisting a Sherrif K-9 video showing a Law Enforcement
Sherriff Car butt up next to me intimidating me. You will see our mouths
synchronize and he mutter something at the same time I do in my car.
You should see this video in a folder named "Evidence – Police Tailing
Me + Other Interactions" This video is found under "Evidence – Police
Tailing Me + Other Interactions"

Is there technology involved now?

As part of the divorce proceeding, the recommendation is for me to be observed inpatient which I am sure folks might be happy to ensure I stay on medication for the rest of my life without trying to figure out what causes for me to be so violent only on the inside of home.

Hopefully, I get to work with you again or some other case worker that ensures of the appropriate due process and can think long and hard of the hell I have lived for every minute of my life for 6 ½ years straight.

I have attached a Behavior Log that shows all my appointments in the community on a daily basis for the last 6 years.

I have also compiled a log for 2016 appointments alone, so that you ask yourself why I did not exhibit this behavior at any of these appointments?

I am also attaching the listed below articles that very simply says it all:
