Hi! Heidi,

Hope you are doing well.

As you know I am going thru a Divorce Proceeding. The Psychological Evaluation and the Custody Evaluation Report after 10 months of waiting based on Bijoy's Testimony, his 2 best friends Testimony and the girls testimony who have been away for the last year states the following :

**Inside of the Home I exhibit the Following :**

- I am vicious and vile
- I spew insane amounts of profanity
- I laugh hysterically for prolonged periods of time
- Laughter and Profanity are all the children hear to the point where they have plug their ears around me to shield themselves from the profanity and the laughter.
- I respond to command hallucinations where I can be driven to any lengths where I still exhibit symptoms of trashing objects around the house, punching walls, banging the steering wheel etc.

Experts from Father and Children as per their testimony in the evaluators reports :

- Father and Children have lived in grave threat every moment of their lives for the last 6 1/2 years
- They are very saddened, they recognize this not their true mother but a demon possessed by her mental illness. Unfortunately they are very tired and they need to move on.

**Observations Outside of the Home :**

- I spend half day outside the home and no one will see me exhibit this kind of a behavior.
- I have spent all day in court settings and these episodes will not come on.
- Prior to 2015 Nov i.e. prior to the divorce proceeding, I spend at least an hr. with other objective 3rd party instructors around my children, and other parents and their children and there are no intake reports from any of these parents exhibiting such demonic behavior.
- Testimony from any 3rd party objective source was not gathered in the reports prepared by the court appointed psychologist or the court appointed evaluator.
- In 2015, I experienced extreme profanity flowing out of my mouth, in their school auditorium as I was standing in the back watching the children perform for which there is an intake report logged by the school.
- I also experienced extreme profanity flowing out of my mouth while watching the girls perform at their choir performance in church for which there is an intake report logged.

As per Bijoy's statements

- This is behavior I experience is on a daily basis on the inside of the home.
- Why are there only 2 public episodes in 2015 - 5 years into such acute chronic mental illness where I have been burgled off every cent, taken over by him in every way possible and abused by him in every way possible?
- Why are there not more episodes in public logged by 3rd party instructors especially when there is such concern for the children?

Recommendation from Psychologist

- Put a court order in Place to observe me inpatient as it is puzzling that these episodes do not exist outside of the home.
- Till I go back on medication and stay on medication I am not to have access to the children.
- After I commence medication I can have access to the children on a supervised setting on birthdays, easter and christmas

### *Eligibility Criteria for Extended Diagnostic Testing:*

- An extended DA includes all components of a standard DA, gathered over three or more appointments. The recipient requires significant additional assessment time due to complex needs, caused by:
  - Acuity of psychotic disorder
  - Cognitive or neurocognitive impairment
  - A need to consider past diagnoses and determine their current applicability

### *Key Components of Extended Diagnostic Testing:*

For adult recipients:

- Appointments may be conducted outside the office for face-to-face assessment with the adult • May involve directly observing the adult in various settings that the adult frequents (home, school, job, service settings, community settings)

This is key as all of the behavior is very symptomatic to inside of the house and is very important to observe me within the confines of my home living my life as well as observe me in court or other community places.

A new extended DA must be completed for an adult:

- When the adult does not meet the criteria for a brief or standard DA
- Who has complex needs and requires at least three diagnostic appointments to complete the assessment, which allows further mental health services for one year • When the adult's mental health condition has changed markedly since the adult's most recent diagnostic assessment
- When the adult's current mental health condition does not meet criteria of the adult's current diagnosis

My Meeting with Dr. Kennedy from Scott County Mental Health Center as of 11/1/2016

He has never seen a case where there is such sharp contrast in behavior of how an individual symptoms comes on inside of the home vs outside of the home.

He did seem to be of the opinion as well where it would be truly beneficial to observe me live my life inside of the home vs outside of the home.
