- b. Proof of Savings Growth to \$40,000 by early 2013 and \$36,000 prior to committal showing that my decision to quit in 2010 has no impacts to household. It is also proof of the fact that it was Joint and transparent before takeover in 2013 where I had no insight into funds – 2012 Statements – Tab C in the Number 6 Evidence Binder.
- c. Mortgage Payments Refinanced – Proof of reasoned decisions when I quit my job in 2010 to make finances work. Tab R in the Number 6 Evidence Binder.
- d. Medical Insurance Payments Refinanced – Proof of reasoned decisions – Pre 2013 as part of my reasoned decision when I quit my job In 2010 – No access Post 2013 to any decision. Tab S in the Number 6 Evidence Binder.
- e. Car Payments all Paid off Pre 2013 – No evidence pre-2013 to substantiate grandiose delusions or magical thinking that led to any irresponsible spends. No Access to any decision in the household post 2013. Tab T in the Number 6 Evidence Binder.

- f. Committal Paperwork 2012 – No Attorney Representation – Binder contains Attorney Notes that shows his minimal representation – Shows him speaking to my family and Ms. Sastri’s family. Their testimony is present in his handwritten notes. His notes has no mention of any cross examination questions. That is the extent of effort that was employed by the state appointed attorney. **Tab H** in the **Number 6 Evidence Binder**.
- g. Committal Lifted within 4 months as oppose to 6 months in 2012. Committal Lift Order filed in Binder. **Tab K** in **Number 6 Evidence Binder**.
- h. 70,000 Jewelry Stolen. Police reports tied to the Theft. **Tab E** in **Number 6 Evidence Binder**.
- i. Proof of Attestation from my parents to the dollar amount burgled. Also contains claims to Insurance Agencies for the theft transpired. Shows my ex-husbands purgered statements where he ensured that the value of what was stolen from him was stated accurately but any value tied to any item stolen from me was downsized and minimized. For e.g. value of his gold ring, Movado watch and ipad stated accurately and he ensured he was paid out. communication received from my case manager. **Tab L** in Number 6 Evidence Binder.

- i. Complete Takeover of Finances post 2013 - No Access to Corporation Registers Post 2013. All Data either wiped out or password protected. No access to any decision in the household or to even what he earns. No access to any policies in the household. I have no insight into what theft values might be on insurance policies, damages might be on insurance polices. He ensured he had access to it all. **Tab U** in Number 6 Evidence Binder.
- w. Evidence of Letters trying to reconnect the marriage. Civil non-existent responses to all his efforts and nothing vicious and vile that he can produce as evidence inspite of allegations. **Tab W** in Number 6 Evidence Binder.
- x. Evidence Countering Irresponsible Spends - Registers (Home & Corporation) - Proof of everything documented and accounted for, today portrayed as OCD behavior – however while it might be OCD to some it still can't be used to refute the fact that there is no evidence of any misuse of funds. All Credit Card Statements 2015 & 2016 provided to all evaluators to counter irresponsible spending. **Tab Y** in the Number 6 Evidence Binder Contains Corporation Registers for 2011, 2012 and Home Registers for 2011 and 2012. It also contains a summary page from 2010 to show my high earnings before my surgery.
- y. Statement & Explanation of rolling invoices alleged in the OFP. MY explanation of all invoices that I rolled out to him in 2015. **Tab Z** in the Number 6 Evidence Binder.

- m. Driving Record – contradicting statements made about rash driving. Shows 3-4 petty misdemeanors and 2 speeding violations for the 7 years of severe illness. **Tab J** of my **Number 6 Evidence Binder**.
- n. Behavior Log – Documenting my daily life outside home since 2010. Years 2016 and 2017 spent in aggressively trying to find appointments within the medical community to challenge my diagnosis. 2016 & 2017 appointment log clearly shows that. **Tab I** of the **Number 6 Evidence Binder**.
- o. Pictures of Celebrations in my household. Proof of no episodes at these events. - Available on Digital Medium – The 2 TB drive I carry in my Purse.
- p. Books Cited in the Evaluation Reports as very grandiose where I required for them to know the name of each bone verbatim. Reality till date – Information present in books Ages 5-9. Printouts of School Websites surprise u when u see the amount of exposure they can have at this age. Science Exhibitions At School– Models of the brain at ages 5 by certain kids at school. – Anything and Everything that he could think of was used so that it could be used to prove what an unfit mother I was to climb back into my ex-husband’s bed for the sake of the children. **Tab P** of the **Number 6 Evidence Binder**.
- q. Pictures of the abuse endured where he refused to train dogs that he bought when I was on medication in 2012 – Pics of the Amount of poop and pee and puke that I clean in a given day inspite of being overloaded with an amplified sense of smell as most Schizophrenics are as they suffer from a sensory overload. Contains pictures of toilets clogged, that for a Schizophrenic mind should be very difficult to clean and deal

- with. She has had no help in the house since 2012 and spent time dealing with leaky clogged toilets that never got fixed, poop, pee and puke from the floor courtesy the lack of training that was not provided to the dogs by him. I had purchased monitors to lay on the floor that would deter dogs from stepping onto the carpet. He ensured that those were never replaced in the house so that I would be forced to clean the poop, pee and puke to see what I would do about it. Tab Q of the Number 6 Evidence Binder.
- r. Exposed to Radiation as of July 2016. Shows pics of swelling, slight burns and rashes that can happen as a result of exposure to EMF frequencies – The Binder Named The Binder that Lays out My Story Carries Pics of the Angioedema and Skin Peel that I have suffered.
 - s. Law Enforcement Tailing Amplified in 2016 – Available on the 2TB Drive I carry in my Purse.
 - t. Electronic Harassment – Documents contains the harassment behavior noted on a daily basis. Forced to print at Fedex since 2014 since my printer was constantly fried and interrupted in the house. – Computers were continually slowed down to the point where I could barely work on it – A Change in behavior since 2014 is reflected in my credit card statements where I began to pay for computer usage time and printing time at Fedex. I have never paid at Fedex from 2010 – 2014.– Called out in my Log. – Evidence on my 2Tb Drive under Divorce Proceeding/Trial Exhibit/Electronic Harassment – Contains Some Videos of the electronic harassment endured. A Device Harassment Binder in Closet contains detail notes of every kind of device harassment endured and how it was used to

- stimulate all the episodes in me. **Tab M** of the Number 6 Evidence Binder contains a brief Summary of what I saw up until 2015.
- u. Copy of the Temporary Order – Shows a grant of \$ 1000 Spousal Maintenance while he earns \$15,000. Shows a grant of 96 hrs on a monthly basis of unsupervised parenting time with the girls. Isolation is automatic as a result thereof as my day to day life was that of an everyday mother that was spent taking care of them which entailed everything at home and their activities on the outside of the home. I ensured I was seen in the courthouse on a daily basis. My license is cancelled as of 9 - 26-2016. Forced isolation and ensured of the force to drive on a cancelled license or summon a taxi on a \$1000 spousal maintenance. Harassed to no end to force isolation but I prevailed and ensured that I never isolated and was always seen on the outside. I put myself thru hell and ensured I stayed calm thru the throes of the sheer hell that I lived. **Tab O** of the Number 6 Evidence Binder.
 - z. Proof of all instruction that my girls participated in canned – intimidation and bullying tactic to see how I would react – also forcing isolation as I cannot go attend any of the activities. I ensured it was all stayed on record. I ensured I kept my distance like the plague, stayed abiding my the order and made sure it was all in writing. **Tab AA** of the Number 6 Evidence Binder.
 - aa. 3-month Index Listing of Video Recordings on Me at Home printed and filed in my Binders. I have recorded myself for a year now.

- bb. All Cell Phone Recordings or Phone Conversations since March 2016 till date. Allegation – My mind flits from one topic to the other and that I tend to dominate conversations as I am very argumentative– Listen to the cell phone recordings – you will find that I am a good listener and I do seem to comprehend the content and answer appropriately. A Copy of all Cell Phone Recordings Available on my 2 TB Drive I carry in my Purse.
- cc. All Voice Recordings - A Copy of All Voice Recordings with all Doctors and Therapists Available on my 2 TB Drive that I carry in my Purse.
- dd. Evidence of asking to be put under surveillance sent to many agencies including Law Enforcement and the DHS. **Tab X** in the Number 6 Evidence Binder.
- ee. Proof that I attended diagnostic testing at John Hopkins Baltimore, for the study of schizophrenia to test how the alpha 7 nicotine receptor binds in the brains of Schizophrenics via the use of MRI Scans, PET Scans, Spinal Taps, blood tests, urine tests and an interview with principal psychiatrist. In spite of being a paranoid schizophrenic, **I exhibited no fear of unknown procedures and no episodes come on inspite of all the needles.** This proof is found in my **Medical Records Binder** for 2016 and 2017 at the last tab – **Tab H** of the binder – A signed document by me with what I was intended to be paid for participating and what I got paid.
- ff. University of Minnesota – Cognitive Testing in Schizoaffective disorders – 6-7 hr interviews spanned over 3 days. **Tab EE** of the Number 6 Evidence Binder shows my signatures.

- gg. Proof of emails sent out to large research programs offered at NIH or the Mind Research Network that offer diagnostic testing for years especially to study schizophrenics **so that case workers who have a difficult time understanding my case, can use it, advocate for me, find the funds so that I may be part of such research programs so that my ailment is understood if they have hard time comprehending that I may be a Victim.** Tab FF of the Number 6 Evidence Binder
- hh. The Medical Records Binder for 2017 & 2017 – Contains records of how much I have suffered Since Sept 2016. Today is Nov 15 2017. I have lived by bunching up large paper towels and sticking it into my underwear. I feel like I am ovulating every minute of my life. I have severe hormonal sensations, constant increased libido sensations, constant wetness in the vagina to the point where it drips, constant mini orgasms in my vagina as I sit working. I have to sit on so much pressure to kill all those sensations. I have to stick a tampon into my vagina. I have to sit on thick harsh paper towels bunched into my underwear so that I can use the pain to kill all the sensations. I sit on ice packs. I have ice packs on top of me constantly icing my groin. After a year and a half of suffering I have a total hysterectomy coming up on Dec 26th. This binder contains my medical records, and pics of the thick inserts I lived with.
- ii. Proof of Services that DHS Can offer – Extended Diagnostic Testing - DHS has the ability to provide face to face Observations in home and in other community places like places or work or elsewhere. In home observations is key as all episodes come on at home. Also, contains the email I sent out to the Department of Human Services asking for in home observations. Extended Diagnostic Testing is applicable to

those people when the gravity of the illness has changed or the applicability of past diagnosis is in question. Binder 3 titled the Closeout Binder – **Tab G** contains the emails sent to my case worker Heidi Schultz asking to avail of the Extended Diagnostic Testing at home. **Also sent out a Drive with recorded Psychotic Episodes at home with a Letter asking for help and asking for the DHS – my case worker (Heidi Schultz) to watch these videos and figure out why this woman suffers as much as she does at home and how is it feasible for to be so normal on the outside. The binder number 4 titled – Letters sent out to All Agencies in my Apartment contains the fedex receipts as proof of delivery in Tab M. Tab Z also shows a copy of all Fedex Receipts that show the number of agencies that were contacted asking for help. Also Tab Q contains a copy of the letter sent to Heidi Schultz along with a snapshot that shows the contents of what was listed or contained on the flash drive that was sent to her.**

- jj. Flew into Sedalia to solicit an Expert. Flew into JFK to hand deliver my story and recordings of me to the NBC Channel by personally dropping it off in the mailbox. No Episodes on Flights. If there were any, I am sure there would be an emergency initiated to have me monitored. After hand delivering videos of my recordings at home to the NBC Mail box, upon my return to MSP – I receive a call that the drive that contained the videos were trashed in someone’s yard. The individual from New York called me asking me if I wanted for him to deliver the drive back to me. Why would the videos that were hand delivered to a person at the NBC drop box center be trashed in someone’s yard?

- kk. Sent out recordings of me at home to family asking for them to take it to a Psychiatrist and ask a very simple question. How is a woman who is so ill on the inside of the home so normal on the outside of the home. Hopefully it gives them some insight into Paranoid Schizophrenia and helps them get past their delusional thought of depressive episodes and what that might bring on. Proof of it exists in Binder 3 – Titled – The Closeout Binder under Tab F.
- ll. Sent out a similar Drive to the FBI, BCA and Wes Abrahamson – County Attorney’s Office and a Letter stating that my illness makes no sense to any one and that I need help. I suffer intensely on a daily basis and that I find respite only in certain environments. I also educated them on the victimization I have endured. Mr. Abrahamson – the county attorney use to see me in the court on a daily basis for 4-5 months straight and I thought I could appeal to the county attorney since he had seen me there and stopped by to chat with me a couple times. Proof exists in binder 4 – Letter sent out to all agencies. This binder also contains proof of fedex receipts that clearly show that letters were sent to all these agencies in Tab Z of this binder as well as Tab M of this binder.

- 1) Put thru hell to solicit Vendor Contracts – After everything is planned, vendors will bail out at the last min.
- 2) I use to work the Happy Faces since the Girls First Birthday in 2007.

- 3) I never had any issues with them from 2007 to 2013. I used them for all my parties on all occasions such as Birthdays, Easter, Christmas in my house.
- 4) For no rhyme or reason she got upset about a charge made out to her that was cancelled. My credit card does not reflect a cancellation but in her mind it did and she refused to work with me.
- 5) I went thru hell trying to solicit and put contracts in place beginning 2014.
- 6) I had to procure vendors thru thumbtack. Website communications would be interrupted. My messages would not be delivered.
- 7) There would be confusion in the contracts inspite of as much put in writing.
- 8) Vendors would call in at the last min and tell me they could not make it.
- 9) At times I would be lucky, but the same vendor that worked well one year might not be able to work for me the next year. Out of the blue inspite of all the flexibility, his calendar would be really full and I wouldn't be able to procure any dates on his calendar and I would have to begin the search all over again and put myself thru hell.

- 10) Tab O in Divorce Close Out Binder documents the harassment I have lived trying to solicit vendor contracts.

Tab H of the Divorce Close Out Binder

Contains my Conversations with ICS – International Counter Intelligence Services Inc., asking for them to monitor me and interview and gather testimony from 3rd party sources on my behalf, and to testify in court on my behalf.

The vendor for such a simple task where he simply needed to meet with people to gather testimony, drew up a contract stating that he would be paid in full if he could not complete the scope of work.

As I was working with ICS, I spoke to many such investigative agencies and was met with resistance, and either no co-operation or no interest in taking on the work.

When I denied such an advantageous contract to ICS and not to me, I found an Investigator Tom Hicks online who promised me he would deliver every facet of the work outlined. In spite of detailed telephonic chats and emails back and forth with as much detail in writing, the vendor did not deliver. When I tried to negotiate a reduced fee, he sued me for harassing him for simply asking him in an email if we could agree to a reduced amount.

The Tom Hicks Case Binder in my apartment closet contains all the details of the case and the harassment I lived on this case. The case was thrown out of court twice. While he could not extort any more money

out of me, I was harassed to no end in costs for travel, preparation for the case and learning the process of how to work with California courts for no rhyme or reason just to see if it would break me. Since I was so anal about keeping everything in writing, he could not hurt me anymore than he tried.

For the last 2 years they see my episodes first hand on the flash drive that I have shared with many doctors. They are not concerned today. They agree it is not schizophrenia and they agree that they do not comprehend it however today in their minds it not medically justifiable to incur costs to hospitalize me, observe

me, ensure of more diagnostic testing like studying my brain activity via an EEG to see what my activity is pre episode, during episode and post episode. Today they have what they need, a mental health diagnosis, a divorce proceeding where the outcome was to grant full custody to the father, supervised time to me, a bait to lure me if I wanted to take up on it – the kids. Why would they be interested in me today after ensuring that my mental health diagnosis gave them what they needed. With that even though my episodes are so intense and are as often as every 3 min, I am no longer a threat as per medical records to anyone, not to me nor to others. That said, I ensured I did not bite on the bait to affect me or to lure me. I stayed candid, stayed on the record with what I showed them and did not give a damn about the lack of response. Their lack of interest in me ensured that they lost the case to commit me by not trying to see what was causing the episodes and I had a stronger case for law enforcement someday.

1. Since my mental health symptoms began in 2010 and since I have been alleged of irresponsible and grandiose spends very consistently, I have complied all credit card statements from 2010 to 2016 for anyone to analyze behaviors and trends.

Lessons Removed From their Schedule – Prior to the Ruling of the Temporary Order . Exparte Initiated on 11/20/2015. All Decisions Quick and Swift made before the Ruling of the Temporary Order on 12/15/2015 – Evidence available in Divorce Proceeding Closeout Binder.

- i. Ice Skating One Lesson Shaved Down
- ii. Dancing – Email received from Dance Studio on 12/09
- iii. Diving
- iv. Sunday School (Alternate Weekends Absent – No Consent from me)
- v. No Choir Lessons on Sunday
- vi. Ensured of No Summer Camps

- vii. Music Lessons Transferred to instructor of his choice with no consent from me.
- viii. Swimming canned now.
- ix. All of these lessons were canned prior to spending \$9000 on Fancy Furniture and inviting his parents over to have the perfect family setup between him, his parents and the girls
- x. He chose to invest in that after canning everything I wanted to raise them with.

Abuse of Joint Legal Custody Award

- a. I had no say in the plans laid out for the kids in the upcoming year.
- b. I had no say in any plans since 11/20 inspite of Joint Legal Custody Award.

Mother Excluded from Children's Lives even prior to the ruling of the Exparte Order

- Children received counseling sessions as a result of a very unstable mother at home who is a grave threat to their innocent lives
- Children received counseling sessions from counselors at school to cope with the trauma they live on a daily basis in their presence

- Mother was intentionally kept out of it and was not even notified that they were receiving counseling sessions either by the school or their father prior to the ex-parte order without an order in place to preclude from any decision that revolved around their lives especially a major decision such as this.

Divorce is a stressor for a normal human being. Can u imagine what a highly emotional unstable schizophrenic must have gone thru in this last year. She spends ½ a day in court since April. Why are there no episodes? Contacts provided to affirm.

She has spent hrs compiling evidence, studying schizophrenia, finding specialists, in the absence of diagnostic testing - finding programs, attending programs to pose her questions and put herself thru diagnostic testing, representing herself, studying the law on her own. How difficult is it for an emotionally unstable woman? Why are there no episodes in court when she is this sensitive and volatile?

She spends 5 hrs in the community with 1 hr face time with an instructor since 2010 till 11/20/2015 when the divorce proceeding commenced. Why are there no episodes? Contacts provided to affirm.

As per her log, her children choir practice in church every Sunday, attend dancing, attend piano playing, attend diving, attend ice skating, attend swimming – children all around at all these activities

and their parents attending these activities. Why are there no intake reports of any odd behavior at these places?

Her credit card statements will prove that she spends time in other kid friendly places as well , All Kid friendly Museums all around town, kid friendly beaches, pediatric or children’s clinics, and dog grooming clinics. Why would an episode not be called in when the welfare of children are at stake? Isn’t that the concern that is voiced the most in my paperwork by other parents?

She has attended every medical appointment with the girls at Southdale Pediatrics in Edina since 2010 – the year of her surgery. The girls medical records provide a detailed history of the mothers visits with the girls. No episodes at any of these appointments. Binder Titled Southdale Peds – Pediatric Visits since 2010 has a log of all the appointments with the girls since 2010. It also contains all the Banfield Appointments – All the Dog Well Check Appts at which there were no episodes as well.

She took care of her 2 dogs and took care of every appointment at the Banfield Clinic without episode.

While her head exploded into every traumatic episode possible as often as every 3 min while she was alone in her apt or household fighting it all on her own, all her so called friends disappeared. Not one person wanted to sit by her side, call every specialist in town, call every facility across the united states, research options available to

me, understand the disease, ask intelligent questions, as to can this be schizophrenia. How can she even exercise any self – control? Why does it not come on in these environments? When I refused to beg for any help in anyone, it was used state that it was my need to isolate when there is a ton of evidence of all the social interactions out there initiated by me and no questions from them on my well-being.

Difficult Elements To Prove

- a. Constant Threats from ex-husband of how easy it is to use the system against her since she has been declared mentally ill in 2012. There is some sworn testimony available as of 2014.
- b. Conditioning of Minds by ex-husband – Complete access to children – Complete control over finances to condition their minds with gifts and what they need. Mentally ill Mother – Wait till 10 years of age to ensure that their statements are used to render no access to children. – Mother has stay away from all confrontations or she gets rendered emotionally unstable even more.
- c. Emotional, Verbal and Physical Abuse – Foul Temper, Shoving, Slapping, Pushing, Constant Control over every little thing he can control, down to opening one’s mail – No privacy, no peace.
- d. Gas Lighting – Little things designed to render you unstable which u try really hard to stay away because you are declared Schizophrenic. Almost impossible to prove as highlighting the individual contexts are not even worth it or it can be used to declare u even more paranoid, except that it continues to get worse – Favorite books moved around, favorite clothes moved

around, credit cards stolen, favorite channels shut down, joint grocery accounts like Sams Club account shut down, maids let go, dogs not trained.

- e. Lack of Credibility – Once Declared Mentally Ill.
- f. My efforts to counter the lack of credibility by ensuring I state it in writing and corroborate my statements with evidence to avoid content left for interpretation was sighted as very detail oriented behavior – A sign of an obsessive compulsive rigid mind. Other signs of an obsessive-compulsive mind such as repetitive behavior where an action is repeated over and over or owning an action that dictates your life for which there is no reason behind it, which are typical signs of an OCD mind could not be stated with specific concrete examples to back it up. Time spent fighting the divorce, preparing evidence and speaking with specialists to offer a plausible explanation was sighted as OCD behavior. I ignored it all and ensured that I stated in writing. Anything in writing backed up with evidence is always difficult to refute. The fact that they call it OCD in itself is designed to ensure that I do not have that solid evidentiary foundational ground. I did the opposite. I ensured of a solid foundational evidentiary ground.
- g. If I state that my statements don't count and if I approach it as challenging questions on grounds of the diagnosis rendered and the evidence at hand – I will be declared with no insight into my illness. Continual double standards were employed. On one hand they did not trust anything I stated because I was declared mentally ill. On the other hand when I provided concrete evidence of what went on to show that I am not delusional they labeled me OCD and wanted for me to simply offer up by statements without offering up evidence to back it up.

- h. Ensured I got paid a spousal maintenance of what he used to support his family with. A \$1000 spousal maintenance when he earns \$15,000. It is an amount he used to pay monthly to his family in India to support them for years. He has probably put in about \$200,000 cash down to support his family that I could have used to cash down pay out this house. Statements of what he paid out to his family available in my safety deposit box.
- i. Intentionally Withheld Legal Documents so I cannot earn from other Sources – Dec 2015 – Feb 2017 – The temporary Order granted temporary joint legal custody to both parents. I had asked for copies of the girls passports, birth certificates and SSA documents. He intentionally withheld the documents till Feb 2017 when the final ruling was passed into judgment as he knew he would be granted sole custody with the way my medical records was positioned and the way the court appointed psychologist and the custody evaluator approached the case where they refused to evaluate any evidence and simply focused only on the mental health diagnosis as it was not their job to evaluate evidence as per their testimony on the stand. He ensured I had no access to those records so I could not apply for derivative benefits as part of my social security disability income. Anything he could do to harass me, minimize what I could avail of in terms of finances and ensure that I break with no resources was employed.

Allegations

- a. Irresponsible Spending – Copy of all Credit Card Statements provided from the get go, but no analysis conducted to determine where I was irresponsible other than blind statements made by ex-husband which was used as the basis of the recommendation.

She keeps invoices rolling and expects for him to pay. When he doesn't she is very vicious and vile – Not a single piece of evidence produced as to her language to him in any written form.

- b. I have claimed at about \$10,000 debt outstanding to me from him for which detailed explanations were provided with no analysis done by any of the evaluators.
- c. Quit her Job Irresponsibly in 2010 – Evidence presented as to the effort she put in to grow savings from 2010 to 2012 which was \$40,000 in 2012 and to ensure of no impacts. A reasoned and responsible choice.

Savings account was completely drained after committal. He took over all accounts, Leaving me with no resources and and no access to any accounts that were once joint - completely ignored by the system. Instead they chose to state it as that since I was mentally ill, he was trying to ease the stress and chose to simply shift responsibility. The fact that I saw it as a complete takeover was a symptom of my very ill rigid mind. The fact that any access to his accounts were entirely frozen especially when they were joint in the household for 16 yrs of the marriage especially when there is no evidence of any misuse of funds was completely ignored by the system. I did not have the right because I was mentally ill to see that as a financial takeover.

- d. Rash Driving – Citations Received till date – How is she an unsafe driver on grounds of what is listed below?
 - a. No Citations till 2012 till I was committed inspite of driving daily.
 - b. 2013 – failure to stop at a stop sign
 - c. 2014 – Speeding

- d. 2015 – Speeding
 - e. 2016 – Unsafe Lane Usage – Not Guilty at Trial
 - f. 2016 May – Used the Shoulder to Exit on to a Hwy instead of waiting in a backed up queue
 - g. July 2016 – Unsafe Lane Usage – License Cancelled for no rhyme or reason based on mental health history and the fact that I have been that outspoken this year.
 - h. Amplified Tailing beginning Early this Year
- e. Psychosis – Unsafe Mother and Threat
- a. Vicious and Vile
 - b. Extreme Agitation – Extreme Profanity - It is all the kids hear – They have to shield them from the profanity by plugging their ears or turning up the volume or hiding in bathrooms.
 - c. Trashes Objects
 - d. Hits Self
 - e. Bangs the Steering Wheel
 - f. Prolonged Euphoria – Laughs Hysterically for Prolonged Periods of Time – It is all the kids hear. They are so tired of it.
 - g. Crying when no one is Watching
 - h. Talks to Imaginary Friends when no one is Watching
 - i. Believes that she is controlled by outside forces

- j. Extreme Paranoia – Afraid to turn the lights on, Outside forces can see in, The Microwave controls her, Outside forces are intimidating her all around, freaks out when she is around cell phones as per the husband’s most recent statement.
- k. Emotionally Unstable - Cannot be trusted – She can be driven to any lengths to the extent to which she responds to command hallucinations - Needs Medication to Stabilize her
- l. No Observations of any such behavior outside of the home – Why? How can such an emotionally unstable person who is so unstable on a daily basis be that calm and normal on the outside for 6 ½ years.
- m. No evidence of any such observations around children. If the children are a trigger that brings on those episodes at home why would the children not be a trigger at these classes and why would I not experience an episode in 3rd party instructor presence? If I did experience these kind of episodes as seen in these camera recordings where I abuse every white whore and white bitch, why would these instructors not protect the other children and parents from such inappropriate behavior?
- f. Rigid Compulsive Mother – Threat to her children as a result of needless demands on them.
 - a. Gets them to learn 2 grade levels up
 - b. Imposes rigid routines where they have no time for anything and are deprived in every way due to the rigidity of her illness

- c. No Evidence besides blind statements

- g. Vicious and Vile – Use of Extreme Profanity in her Language – Not a Single Piece of Writing can be provided proving that or an interaction from a 3rd party source to prove that.

- h. Children are Afraid to Socialize in fear of what their mother might do at a party – For Years Children are invited over for large scale celebrations to their home. If there is fear in the community, why would parents send the kids over for all these years. – No Evidence – I have plenty of evidence in terms of tons of pictures of how large scale these celebrations are. The closet are filled with tons of albums for every year showing the large scale celebrations and tons of pictures of all the kids at these events including classmates from school. After abusing every white bitch and every white whore as seen in my video recordings why would these parents from school continually send these children over to my parties?

- i. Statements such as these were used to grant sole custody to the father.

- j. Recent Psychological Profile as Part of the Divorce Proceeding –
 - a. Sensitive to Criticism – Can react in negative ways and force her emotion onto others. Anger is apt to be expressed in

indirect and manipulative ways. Could become critical and argumentative to defend her ways.

- b. Schizoid Profile – Cold and Devoid of Emotion – No Use for any friendships – inline with her profile in 2012
- c. Obsessive Level of Detail

As Per Psychological Testing :

- 1. Sensitive to Criticism : 10 months of no access to anything – slammed at every turn and litigation prolonged. Did they see an episode come on in court? How is she sensitive to criticism causing her to want to project her angry feelings on to others?
 - a. 11/20 – Exparte Initiated
 - b. 12/15 – Temporary Order Ruled
 - c. 11/20 – 12/15 – Every pattern that she set in place for the kids taken over and canned or modified to see how I would react. Why make decisions even before a Temporary Order is ruled?
 - d. Hearing in February – Last Minute Cancellation
 - e. Motions to request that patterns get re-instated or that I get heard shot down and asked to be resolved thru Custody Evaluation
 - f. Custody Evaluation Report due to be ready in May – Extended – For a report that was suppose to be ready on May 17th a request for Psychological eval

gets puts in on 4/21. How on earth did she plan on accomplishing her goal?

- g. Custody Evaluation Report Due to be ready in July – Extended Out – She had to attend a Burial
- h. Custody Evaluation Report Due to be ready in August – Extended Out
- i. Custody Evaluation Finally Ready in September – 9/27 – Comprises of 2 best friends testimony that she simply wrote down and did not even question, 2 children’s testimony conditioned by father for 1 year as mother has no access, His interview, My interview and my Parents Testimony
- j. A Truly through evaluation – Pardon the sarcasm
- k. Custody Evaluator had 10 months to prepare such a report and state her recommendation in which she states that I not have the ability to have access to the kids unless supervised.
- l. Trial was scheduled within 3 weeks of such a report. I had only 3 weeks to prepare when she had 10 months to compile a 30 pg report based on testimonies that she wrote down blind.

2. Cold and Devoid of Emotion – She is alleged to be incredibly emotionally unstable where she is a grave threat. How is she cold and devoid of emotion? I am not sure a woman can be so volatile, so sensitive, so emotionally unstable and cold and devoid of emotion at the same time. Those are very contradictory statements. However, when I question it, a case worker will state it as

“ she exhibits a lack of insight into her illness”? Am I paranoid to see the obvious?

3. Obsessive Level of Detail – How does that contribute to the key question that still needs to be answered? How is a person so uncontrollably volatile responding to internal commands to the extent she is that calm on the outside for a tenure as long as 6 ½ years? To this date the evidence compiled has been strictly in the context of the allegations rendered by my soon to be ex-husband. Is it not standard process to present evidence to counter allegations?

A Poor excuse for forensically analyzing all the organized evidence presented as it truly makes it difficult to ignore the evidence.

Lack of Insight Elements

- a. Seeing Family as a Threat to her Life – Marked Symptom of Schizophrenia. She recognizes that it is “THE KEY” that I get honed in on
- a. What is so wrong with that?
 - b. Highly Educated Parents – Plenty Money – Globe trotted across the world – No surprises on lack of attorney representation
 - c. Encourages the daughter to sleep with her abusive husband

- d. Their statements to me were make it go away by sleeping with him or medicating yourself. In other words, It will get all better if u just bend over and stay fucked.
- e. No surprises at the fact that I become this sick after a surgery in 2010. Not one curious question as to what about that surgery made her this ill only on the inside of the home for 6 years straight?
- f. No surprises at the abuse
- g. No surprises at the jewelry stolen
- h. No surprises when they see her psychotic inside of the house spewing profanity and laughing hysterically.
- i. No surprises when they see her go to classes each day and watch her not scream or spew profanity or laugh hysterically.
- j. No surprises, No questions on why she is so demonically ill inside of the house.
- k. They would advocate for me to stay medicated with no research on their parts to understand schizophrenia
- l. They never stood up for me and offered statements of the abuse they witnessed. Instead they would let police officers commit me and keep their mouths shut in their presence.
- m. They are here for 2-3 month periods, long enough to make good observations. They were here in 2011, 2012, 2014. Why were there no attempts from them to fix the situation? Do they not portray themselves as an incredible loving family that supported her? What attempts were made by

them to advocate her case, use their money, ensure of a sharp lawyer and free her from this mess?

- n. As per their statements, my mother maintains she did not see any observations in 2011 and 2012. She states that she only **heard** and **did not see** me spewing profanity and laughing hysterically. She maintains that I exhibit such a behavior only when I am alone. She also states that when she gets downstairs I am calm. She also states that she has intermittently seen me talk to myself in the mall. She vehemently insists that such a behavior is brought on by depression and that on the outside after responding to auditory and visual hallucinations to the extent she is, she is very conscious of her environment when she gets outside and has the ability to stay in control for a period as long as 6 ½ years ON A DAILY BASIS. **At home her environment tells her brain that it can stay unconscious and she can freely talk to her environment all around her.** That's the level of insight my parents have gained after having a daughter who suffers from paranoid Schizophrenia that has never had any remission from such an unstable volatile mind for 6 years straight. They also maintain that the home that has many unhappy memories and that the home brings it on.
- o. In 2012, my father portrayed himself as a father making very tough parental choices to stay me on neuroleptics since it was the right thing to do to ensure that I got treated. Given his tough choices based on his deep knowledge of the subject and his intense involvement with my psychiatrist from 2012 (pardon my sarcasm), why is he is not surprised when he sees me respond to command hallucinations to the extent I do, inside of the house and sees me that calm with

an ability to not respond to the command hallucinations outside of the house? He spent 2-3 months in 2011, 2-3 months in 2012, 2-3 months in 2014 just like my mother and sister did. Such highly educated, such intelligent people. Not one question posed. Why?

- p. When I continually challenged them about the lack of episodes, the story changed in 2017 when they visited me. They saw more on the outside and they tried to use that to challenge me back that there were episodes in their presence outside of the home to show me that I was exhibiting a lack of insight into my illness.
- q. So I did the opposite. I challenged them with the appointment log that showed a series of appointments with doctors and courthouse appointments with no episodes. So I asked them to think even more? Why would u see episodes in your presence today outside of the home? Is it because I have gotten so much more open about the lack of episodes at all these places? **Do u think someone is trying to intimidate me even more?** Of course I always received blank stares. They never seemed to ever comprehend **motive, domestic violence, abuse** other than simply staying dumb and asking me to stay medicated and climb into his bed.
- r. Why should I see family as a source of support?
- s. Since 2014, she has 557 emails out there trying to find a job and was not able to find a job. With everything taken over, no access to any decision or any funds, she solicited financial support from her parents during her divorce proceeding for which she was more than happy to provide all her credit card statements for inspection such that they can uncover

frivolous spending? Should I view some financial support rendered during the divorce proceeding in light of what I have suffered and endured for 6 1/2 years as incredible loving support from a family that was here for 3 years in a row, watched me suffer, did nothing and amplified the abuse. Should I view some finances rendered to me in the light of what they have earned and enjoyed their entire life, realizing every dream and happiness that was precious to them when all my dreams and my innocent children's dreams were steadily raped, especially in light of the fact that I never took a dime from them since 1997 - the year in which I landed in the United States till 2015, when I was forced to take some support from them as their love and support?

- t. She has spent her life living on a \$1 sandwich and a \$1 coffee from burger king while my father globe trotted 77 countries, changed an expensive classy suit on a daily basis and lived in 5 star resorts when he globe trotted. Should I be thankful to such a man who realized every dream of his and cold bloodedly murdered me by owning such a callous disregard of my life and my 2 innocent children's lives.
- u. My sister owns 3 fancy homes paid out in cash, gorgeously furnished with classy expensive furniture, one in Bombay, One in Pune including one in Dubai – one of the most expensive cities - a spacious four bedroom with a fancy all glass four season porch, private courtyard with a fancy swimming pool, a hot tub, all landscaped with beautiful flowers and lighting, beautiful front yard all in the heart of Dubai, fancy jewelry, designer clothes, private fancy schools for her daughter after offloading 2 step children and kicking

them out of the house. She has some gall trying to tell me how to run my life. Not only did she have the gall to ensure of her high handed interference, she had the gall to feign absolute ignorance about the grave impacts to my life and my innocent children's lives and all the dreams I had to raise them in private schools with a great future when she rendered her whole hearted support to an abuser and ensured a mental health diagnosis for me with no questions asked and no curiosity into why a woman who earned \$200,000 magically becomes so ill after a surgery with no signs of these episodes outside of the home especially when she is being abused to the extent she is and especially after her severing the marriage right away after that surgery. What about that surgery made her want to sever all ties that bad?

- v. My parents own 2 beautiful homes, 2 chauffer driven Mercedes cars, maids in the household, fancy furniture, designer crockeries, designer clothes, fancy jewelry and they have the gall to not even want to figure out what went on with my innocent life. Instead they exhibit the gall of flying into Minneapolis in 2012, speaking with such conviction to stay me medicated and offer my life to a third rate thug that uses that record for the rest of my life to ensure me with no options and choices.

- b. The Entire World is against her and that she is a victim of the system setup by her husband?
 - a. What is so wrong with that?

- i. Emotional and Physical Abuse as attempts of trying to re-connect the marriage. Continually refused. Abuse amplified as a result of my refusal to reconnect the marriage.
- ii. Involuntary Committal – On his word and best friends word alone that was not even cross examined
- iii. No surprises at lack of representation or the helplessness she should feel as his victim
- iv. Mental Health Profile publicly available on portals.
- v. How should she feel when every person knows her as an unstable woman? She has lived by smiling into their faces and owning her world not letting anything get to her?
- vi. Burgled of every cent
- vii. No attempts from Law Enforcement to communicate with me on grounds of mental health.
- viii. Complete financial takeover inspite of the savings grown to \$40,000 and the \$66,000 of savings put into joint pool on a 6-month contract she earned while on harsh medication.
- ix. No insight into how she should feel when she has no insight into any decision in the household especially when she ran every cent that open and transparent pre - 2013.
- x. She always ran her show as a very independent woman. Why is it not an attempt to break her when everything is taken away from her? How should a

strong independent kid feel when she needs to be accountable for every action to him?

- xi. Continual Gaslighting
- xii. Abuse not even taken heed of by Law Enforcement on grounds of mental health.
- xiii. Continual Electronic harassment
- xiv. Refusal to Train Dogs after they are purchased with money from her 6 month contract – Why would you purchase dogs without any insight into what it takes ?
- xv. Maids Let Go
- xvi. Claims of how devastated he is – Claims of how threatened he is – Claims of how he has lived his life in fear every minute of his life ?
- xvii. Why wait till the girls are 10?
- xviii. When a woman is this volatile and unstable capable of doing anything why would you not keep the children safe? Why would u wait 6 ½ years? How does that make any sense?
- xix. No surprises as to why a woman is this volatile and unstable inside of the house – How is she that calm on the outside of the house? How can that not surprise him?
- xx. As per his statement in court he claims that I just stand there screaming and getting my job done while I am screaming at something in the environment. When asked why there are no observations on the outside, he vehemently insists that parents do walk up to him

and complain. He cannot however answer why parents are so quick to log reports in school on the 2 public episodes and why other parents that have walked up to him would not do the same and log a report especially when it is a school or another class or activity in a public place.

- xxi. No efforts put in to educate himself into what true schizophrenia is like?
- xxii. **Why not record her volatility and share it with a psychiatrist to get an opinion?** Mother States that she has viewed recordings recorded by the husband on cell phone. Husband did not share those recordings with the evaluator or the psychologist. I asked for her to draw comparisons from the videos I sent her to what she saw on husband's cell phone. Why would u not want to know what is wrong with her especially when you see her that demonic and that calm for 6 ½ years especially when a surgery wrecks her life? How can u not be curious about what about that surgery made her so ill?
- xxiii. **Why not get a private investigator to record her and share it with the court? Why offer 2 best friends testimony that he can bank on and not a single 3rd party source from all the classes she has a presence at?**
- xxiv. Schizophrenics are not a split personality disorder. She lives a split personality every single day. What is wrong with her? Why does that not surprise any member of her family?

- xxv. No surprises even when she was burgled. Is there any evidence of him wondering if someone could be trying to hurt her i.e. assuming that he is so naïve where he does not even get that a woman this ill inside of the house cannot be that calm on the outside of the house.
- xxvi. Continually gloats his mock into my face because he knows how helpless she truly is when he has a system to aid him. Once you are declared mentally ill it is an ACE for life.
- xxvii. He claims that he will do anything to make her happy to avoid any episodes coming on that leads to foul temper and extreme profanity to shield the children.
- xxviii. She has no jewelry, wears a \$50 watch, runs a run down car for years, owned a cell phone without switching it out for years, does not wear fancy clothes and stays away to the best she can. What is it that he did for her to appease and please his very demanding wife?
- xxix. Continually Defamed – Statements from maids and husband and his best friends will be used. As per a police report, a maid stated that I displayed a knife in a threatening Manner and that she was afraid to work with me. On the flip side the report will also read that she worked with me 18-24 months. Is there a shortage of jobs where a woman has to work with her employer for 18-24 months in fear? Why work with me?

- c. Heresay Statements – I makes it a point to put down my statements in writing and provide evidence to the best I can and hold myself to it. However, my committal in 2012, 2014 and the divorce proceeding was entirely based on a person’s ability to simply state anything they pleased and not have any fear of being summoned to the stand. There was no thought put into what the impacts to my life were based on these HERESAY statements – my challenges on the grounds of my life having been victimized on such hearsay statements was seen as lack of insight.
- d. My challenges to the system as to why did people not come forward and report weird behavior if they did see me exhibit any episodes prior to 2015 was declared lack of insight.
- e. Why does the system get to make decisions and amplify the gravity of the situation of why I needed to be removed from my children’s lives when the complaints/statements received boil down to some speedometer parked in the community to collect evidence on rash driving for which there was no evidence, 2 speeding violations since 2010 and 3-4 petty misdemeanor citations where I forgot turn on my left lane indicator, did a rolling stop at a stop sign, and 2 episodes of psychosis in the community in 2015 prior to the initiation of the divorce proceeding in Nov 2015 over a tenure of 5 years since my surgery in 2010. A parent is removed as a grave threat from children’s lives after the level of endangerment is proven. What evidence did they have to prove that level of endangerment based on what was listed in the OFP and the evidences that were provided?

- f. Why do I not get to challenge the system on the absence of episodes till 2015 especially in light of the fact as to how ill I am inside of the house? Why do all the evidences not point to a typical case of domestic violence to render a spouse emotionally unstable in every possible way, traumatize her to such an extent that she is forced to bury herself in some institution and loose whatever little she has left in her life? Why does this case not reek motive in every possible way?
- g. A recent lab sample of hair analysis shows that she is exposed to radiation. Why does that not reek motive? How difficult is it for a woman to find all the resources within a system that she has no experience in with such little funds? Why is the need to ensure that she has such little funds not motive?

The radiation report could not be submitted to court as it amounted to heresay evidence as a representative from the lab could not be present to testify. However, the 2 best friends testimony written down blindly by the evaluator without question as per her testimony in court on 10/19/2016, when challenged as HERESAY from me was ensured of as "Lack of Insight" into what a custody evaluator's role should be. Why does the court need a court appointed investigator to write down statements blind without question? I wonder why a forensic psychologist was appointed? Isn't the role of a forensic psychologist to investigate?

How can I ensure all by herself with such little resources that every piece of evidence is authenticated and up to the standards

of evidence that the courts need. Why am I held to such high standards and not the petitioner? Why is that not motive? Exposure to radiation is an important piece of evidence that got shot down.

Victim Behavior

- a. Avoid Confrontation at All Costs
- b. For a while after her initial reports into Law Enforcement she refused to say much in fear of how it would be used back as her initial reports were not received as the Law trying to help her in any way .
- c. Realized that her silence gets used back too. She stayed candid in written statements and walked away with no expectations of any kind of help.
- d. Some Victims get emotional about how they were dealt a raw hand. When you are a Schizophrenic, an emotional volatile mind as per the allegations is what they look for.
- e. I smiled thru it. If not anything it is proof of the fact she does not experience the emotional behavior in public.

The episodes described in my paperwork cannot be viewed as simple agitation as a result of an illness as much as case workers and doctors want to minimize it today, as it is contradicted by the extreme command hallucinations she experiences when she displays aggressive behavior such as extreme agitation, slapping herself, trashing objects, punching walls, displaying knives, laughing or sobbing

hysterically, laughing for prolonged periods of time, driven to the point where she is capable of anything hurting herself or others as described in my ex-husband's words in his affidavit for which not one ounce or shred of evidence was provided.

Such extreme agitation proves that I do not have control over such a mind.

You cannot experience such extreme agitation or such extreme hysteria or euphoria on a daily basis and show such remarkable self-control and smile thru it all for a period as long as 6 ½ years. If such was my control why would I not exercise that kind of self-control at home? Why would the lack of self-control at home play right into the legal system which would enable the legal system to let them strip away that much from my life?

Why would I not trip up in public especially when the episodes are that INVOLUNTARY AND UNPROVOKED when the tenure is long as 6 ½ years and I am on the out and about on a DAILY BASIS?

- f. How is the argument lack of insight not a need to shut me up when they do not have any answers or when they refuse to answer the question?

Other Elements I did Right

1. I stayed consistent in my patterns and behavior.
2. Always smiled, always stayed calm.
3. Kept my regular profile other than quitting my job in 2010 and ensured that I was a very engaged mother always very busy, had face time on the outside and had the evidence to back it up.
4. After I went back to work in late 2012 for 6 months, I ensured that I documented all my vain attempts to continue to find a job which no matter how hard I tried I could not find a single job post May 2013.
5. Ensured I was always thoroughly documented and maintained logs of everything I did.
6. I never isolated.
7. I trusted my instincts and severed all ties with all my abusers without isolating and not letting them use it against me. When they tried to say that severing ties was a symptom of my ill mind, I stood strong and refused to let them back into my life. Instead I countered everything that they had to say by stating that they should answer the premise of the question first? Why are there no episodes on the outside of the home? Why a surgery? How I chose to see my abusers was entirely secondary to the premise or the key question that needed to be answered and was quite honestly none of their bloody business.

8. Ensured I recorded myself with a camera when I was alone working
9. Ensured that I recorded all my therapy conversations as well as conversations with all my doctors
10. Minnesota Law enables me to record any conversation as long as I am a party to the conversation. I maximized my advantage and always used this element of the law to my advantage. It does not require for me to disclose that I am recording the conversation and I intentionally did not. I simply took advantage of it.
11. I kept a through log of all my spends. Ensured I adhered to my budgets.
12. I kept my day well recorded.
13. My calendars were always up to date including how I spend my time and what I worked on.
14. Kept backups of all my data.
15. My cell phone was continually backed up. My cameras were backed up.
16. All Backup drives were labeled and stayed in safety deposit boxes in the bank.

17. Ensured I put all my symptoms on the record and on my medical records. I ensured that my video recordings were shared with doctors after the divorce proceeding was commenced.
18. I always ensured that every element was a lie at his end by making sure that my end was that clean and on the books. I had nothing to hide and I ensured of it.
19. I chose to make a concrete ass out of everything he presented.
20. I ensured that I never let anything intimidate me. What is the worst that could happen? That the person doing this to me would put my children thru the system. I ensured he did just that.
21. I stuck to my guns back then. I stick to my guns today.
22. I stayed my children out of it to the best I could. They don't know how I suffered and I ensured I stayed a very clean equation. It gave me more power to ensure of my safety and ensure that they were safe with an abuser till I was ready to yank the plug and walk to law enforcement.

Evidence for Police Tailing Amplified Available on a CD - Video Timings :

Video 1 - shows 2 units both parked on the shoulder, and one moving into traffic after she passes by tailing her for a distance. The video shows the first unit parked commencing at 00:26:34.

Video 2 shows an unit stopped at a stop sign on Fourth Avenue on her return from the court house, moves into traffic as she passes the stop sign and stays behind her till she makes a left turn to head onto 169 S. Tailing begins at 00:23:46 also showing the police car driving on the shoulder for a little bit. It is her everyday routine and habit to spend the morning at the courthouse taking in how lawyers present their cases as she is representing herself in the divorce proceeding.

Video 3 shows me leaving Cascade Bay after spending an afternoon in the water park with my girls. A police unit was parked in the parking lot. He backed out of the parking lot at the same time I did, and stayed behind me till I made a right turn into another parking lot to get out of his way. Tailing begins at 19:06:32.

Video 4 shows a Police Car from Edina where my girls go to school tailing me at a distance on my way to the Courthouse in Shakopee. It seems strange that a police truck from Edina would want to tail me in Shakopee on my drive from home to the Courthouse. I notice the tailing begin on 169 S headed toward Canterbury Rd. He stays behind me till I make a right turn on Cty Rd 16 to head to the Courthouse.

Video 5 shows me leaving the courthouse, a unit stationed at a stop sign and pulling in after me as I pass him. The tailing begins at 19:06:32.

Video 6 shows me leaving Office Max, a unit stationed close to Office Max and entering traffic as I leave. It shows the cop car sliding out of Office Max as soon as I leave from the get go.

Video 7 shows a unit tailing me as I drive to Burger King for my morning breakfast. Driving to Burger King and the Court House are my everyday morning patters.

Video 8 shows a police unit right behind me as I enter the Bloomington City Attorney Office to Request Paperwork with regard to the citation received on 7-26 and the cancellation of the license. Tailing begins at 12:48:00


The videos spot Law Enforcement paying me as much attention over a span of 6-7 weeks that I have never experienced.

I have other videos that show them stationed around me when I go to the retail stores such as Walmart that I have not wanted to raise as the first thing that will pop out of most minds is that she is a paranoid mind as a result of her mental health.

As stated in my written arraignment for the citation received on 2/11/2016, I just have to trip up a couple and they know it and they are right there citing me. The citation received on 5/4/2016 was a result of me trying to attempt driving on the shoulder to get onto Hwy 13 without waiting in a queue that was all backed up. Like I said I trip up a couple and they are right there to cite me. It doesn't take too much for me to get cited.
