

Key Arguments My Lawyer Should Make

- It is key to figure out why does she have these episodes only on the inside of the home barring the 2 intake reports right before her divorce proceeding in 2015?
- Why does it appear that her episodes increased in frequency while she was alone in the year of 2016?
- Why does it appear like she declines to no end on the inside of the home when she is alone?
- **Observe her for a period of a month or 2 if you like without any drugs in a facility under the watchful eye of a camera so that doctors and she may be able to watch the recordings together and compare it to the episodes when she is at home? She has 5 months of recordings on her which is a pretty long tenure to compare against to figure out what the variance might be if any after she is observed for a month or 2 in a confined facility?**
- **After 6 years of living such a psychotic state which is available in her mental health paperwork as well as the 5 months of recordings she can provide, where she lives her day breaking into involuntary laughter or such involuntary extreme agitation or profanity as often as every 3 min she truly should not be in a position to exercise any kind of self-control for an observation period of a month or two**

- It is also imperative to note there is no reasonable explanation behind why she would want to break into such extreme laughter or such extreme episodes of rage and profanity every 3 min on the inside of the home when she is all by herself simply trying to work.
- There is ample evidence of the fact that is all she is trying to do.
- Given that she is in a confined facility and given that she has been able to take care of herself for an entire year living by herself, represent herself thru very stressful situations since Nov 2015 and manage every element of her life singlehandedly, inspite of the hell she has lived and given that there has been no evidence of physical harm or violence to anyone in her care, it is safe to say that the court would not need to worry about the respondent hurting herself or others.
- **I think the answer should present itself.**
- Witness testimony from the contacts that she has provided, to compare her demeanor at these activities as oppose to what she experiences in the home should contradict what is seen on these videos especially when she is around children in these classes. Any responsible instructor should call in a psychotic woman in this kind of rage and hysteria especially when she is having episodes around children. Letters of Reference Available.

- It is also imperative to acquire testimony of her family which includes her mother, father and sister in the form of a deposition such that their testimony can be examined to draw comparisons for what their observations were in 2011, 2012 and 2014. As per her statement they have spent 7-9 months over these 3 visits when she was still experiencing incredible psychosis. It is important to understand why her psychotic state shuts down in a person's presence especially when her psychotic state is not that of intermittent episodes rather one where she has no control over her involuntary actions and as OFTEN as every 3 min. It makes no sense for such a vulnerable brain to shut down in a person's presence if she is truly mentally ill.
- It is also imperative that their testimony be gathered as to what their impressions were of the entire month of recordings that she sent them on November 10th 2016. She also sent them another flash drive containing 80 videos of a weekend in January 1-10-2017 to 1-13-2017 where she was experiencing psychosis every 3 min while she was in the household to show them how stimulated she was and the attack she was under. She also sent a flash drive of another weekend filled with Psychosis on 2-27-2017.
- She has continually asked them to think back to their visits and document their testimony as to what they saw with as much detail as they can in all the 3 visits since 2010.

- As per her email communication with her family it seems like that her mother and father may have some constraints flying in. Apparently, her sister brother-in-law do have the bandwidth both in terms of health and finances that their presence be solicited i.e. assuming that there is a grave concern for her well-being.
- In the absence of their presence their testimony deposed is incredibly important.
- It should also be noted that her family expressed a lot of interest during her committal phase in 2012 and worked freely with the psychiatrists in 2012 and wanted to render her their support while she was on neuroleptics.
- She asks that they do the same again.
- It should also be noted that she has asked family to fly in for the last 4 -5 months now with no success. A person's presence in the house could have saved her life especially in light of the fact that a Private Investigators Presence for 2 days did not bring on any episodes. She also asked for them to fly in and help her seek medical attention at research programs that have the ability to offer her sophisticated imaging to study her neuronal chemistry and study her brain reactions in correspondence to an action that she is performing such as typing at her computer. It is very important that they see the episode come on under EEG or imaging equipment other than simply medicating her so that such

a report can be presented to figure out if she is being hurt in some way in her home.

- She has fought the entire year single handedly trying to amass as much literature as possible on Schizophrenia, Divorce Law, EMF Devices, effects of exposure to radiation, working the Legal System, Working the Medical System asking to be observed for her to see what her episodes would be like in a hospital without any luck in soliciting help to get her admitted for a short period, trying to meet with experts out of state by attending research programs on a \$1000 spousal support without trying to hurt herself, take her life or anyone else's life.
- She fought the entire year while her head was exploding into as many involuntary episodes every 3 min of her life. What has she lived? Why would family not want to help her in that kind of situation?
- The only way to know what brings on that kind of intensity of episodes on the inside of the home is to observe for a long tenure of 45 – 60 days outside of her environment to figure out what might be going on with her.
- She also received no communication from any friend or acquaintance or even a call from anyone checking on her. Anyone's presence in the house could have potentially made a difference especially in light of the Private Investigators report.

She had to spend \$3500 on a \$1000 spousal support to ensure of that piece of evidence.

- What kind of position could she be in inside of her home when she has no funds, her mental health is public knowledge and especially when she is stolen of every cent without any help?
- It is also very important that everyone see that she developed **this magical phenomena right after the day of her Surgery in 2010.**
- **She also has evidence that shows that SHE IS EXPOSED TO RADIATION.**
- In light of the fact that she has experienced as much psychosis right after her surgery ONLY ON THE INSIDE OF THE HOME SINCE 2010, physically and emotionally abused, stolen of \$70,000 worth jewelry, reduced to a \$1000 spousal support, no help from anyone inspite of repeated requests to help out – HOW CO-INCIDENTAL IS IT ALL?
- The only way to know for sure if she is being hurt in some way inside of an environment is to observe her for a couple of months out of her home to see what the difference in intensity is before putting her back in her environment along with a security expert or an electronics engineer that can help test and monitor EMF Fields.
- She has done research and is able to provide me with a list of devices that may or may not help measure the extent of radiation she is exposed to, She has continually experienced her devices

hijacked. She needs an expert to help monitor her fields and the activity on these devices.

- She is also able to provide a couple of names in the industry that the Guardian Ad Litem may be able to work with such that the appointed Guardian Ad Litem might be able to work with Law Enforcement to provide the necessary resources (such as electronics expert or a Forensic Expert with expertise to monitor her at home for exposure to radiation or to monitor her electric fields) to see if the episodes will re-occur at home while being monitored under such equipment or while wearing EEG Gear or other monitoring devices that can monitor her electrophysiology while having face to face observations at home that the Department of Human Services can provide her with as part of their Extended Diagnostic Component Feature.
- **She also sent the Department of Human Service a drive filled with a month recordings of videos of her in a psychotic state asking for help.**
- **It is key to figure out as to why her episodes magnify in the intensity of what is observed on these videos only when she is alone in the house?**
- **It is imperative that doctors provide at least a case from medical history that has shown her kind of intensity with the emotional incontinence she experiences only within the confines of a certain environment and is able to move into a**

different state of calm and normalcy when she is out of that environment for a tenure as long as her i.e. 6 ½ years

- She is able to provide at least a case from the court systems while there are many such cases out there that shows how a person can be stimulated and electronically harassed from the outside. How does that make her a paranoid schizophrenic when there is not a scientific explanation i.e. a medical explanation for what she has lived.
