After we move out of this house and u have an opportunity to observe me and the recordings at the end of each day for 3-4 months we will need the money to consult a private lawyer and speak with other agencies to ensure of a better decree where I did not get paid out my share on any grounds.

I may or may not have these episodes on the outside of the home and it will become very important to understand to what extent I have these episodes outside the home in your presence and compare them to what I have lived for the last year and half in this home.

After that I would like to ensure I check into a psychiatric unit to ensure if the pattern prevails in there while I am continuing to work with doctors in the system between now and then so that all of that information can be taken to a law enforcement agency.

Also between now and the next 3-4 months I have a couple of private detective agencies that I might be able to reach out to that might be able to educate you on electronic terrorism and what I have lived and suffered.

Also are u planning on travelling alone or with mom. If u are travelling alone, I would like to make sure Shai flies in with you or Mom does. Either way what matters is what u write down at the end of each day in a report that will need a maintained on a daily basis.

For the last year and 1/2 I have lived on a \$1000 spousal support.

My expenses on a monthly basis with legal expenses is \$2500. My debt has continued to climb where I have lived on \$2 bck coffee and 2 bck chicken nuggets as affording decent grocery on a \$1000 is not possible.

Today I have had to stack credit cards and try to stack that credit in the hope of finding a job so I can pay it out.

As of March 1 I receive \$4050 for my expenses.

Listed below is what I have to account for

\$1300 - Rent

Utilities may or may not be included

Auto Insurance - \$300

Medical Insurance -\$500

Auto Loan Payment - \$500

That is \$2600 just basic costs with nothing else for a tiny apartment unless u are willing to pay for more to keep me comfortable

The current medical plan allows for a 20% co-insurance that I have to pay for because the court order did not account for him paying him the co-pays.

Those are medical bills that need to get paid out along with other medical bills that I am responsible for.
