Enclosed in the Packet is the following as I indicated I would provide in my last email communication to Dad and Mom on Jan 12th 2017.

- Private Investigator Report of 2 Day Video Surveillance – I hired a private investigator to surveil me for 2 days to see if my episodes would be any different in a person's presence while I am going about my day as I always do inside of the home. It was also an attempt for a 3rd party person to capture the involuntary emotional reactions flowing out of my mouth. As expected – in 3rd party presence, inspite of experiencing such explosive psychosis as often as every 3 min for 5 months straight i.e. just the time I was able to record myself not to mention the number of episodes I may have experienced when I am alone on the inside of the home prior to me being able to get cameras up and running for 6 years straight since the day after my surgery – I experience no episodes when he is at home for 2 full days. I experienced a very light laughter episode at the end of day 2 which is negligible to what I live otherwise.

- 80 Videos All Cataloged of a very recent weekend (1-10-2017 To 1-13-2017) showing me incredibly Psychotic as frequent as every 3 min while in the household. This weekend is post the Private Investigator Visit and shows the same symptoms as I always experience while I am in the home (extreme agitation shaking with rage and saliva flowing out of my mouth like I want to kill someone with my heart racing, extreme euphoric laughter, sheer garbage and profanity flowing out of my mouth). As always after the few min of extreme rage, euphoric laughter and sheer garbage flowing out of my mouth passes, I return to work and I force that habit to prevail. It keeps me alive.
- As always, I also ensured post the Private Investigator Visit that I spent time in a hospital ER lobby for 3-4 hrs at a stretch recording myself cataloging videos i.e. while working on my laptop like I do at home. Not one episode came on.
- This flash drive, also contains Park Nicollet Visit Notes i.e. Notes from all my Doctor Appointments for the year showing me alert and oriented and not experiencing an episode like this at any of these appointments
- In spite of the constant psychosis and the stress the brain is under, the brain does not involuntarily fire at any appointment.
- It also contains the Custody Evaluation Report containing Mom and Dad's statements since they were curious about what went on during the Divorce Proceeding.
- I am also attaching the Court Trial Transcripts so u know all the questions that were asked during the proceeding.
- If u are interested in learning more about Schizophrenia or other neurological disorders such as Psudeo-bulbar effect that can cause emotional incontinence causing the brain to fire involuntary emotional reactions such as sobbing, breaking into euphoric laughter or agitation outside of their control, I have compiled a ton of information as concisely as I could on a website as listed below : <http://www.avictimoforganizedcrime.com/>
- I have also compiled information on exposure to radiation and what it can cause and what symptoms one can experience when exposed to radiation.

- I realize u have limited resources to educate yourself, hopefully u find the resource handy. It contains videos and articles in the most simplest form that is highly educational and that is kinda impossible to not comprehend.

- There are also pictures attached of the thick inserts I insert into my underwear and sit on so that I can block out the sensations of my ovaries being stimulated.

It is very important u have your statements handy for what you saw during your visits when u spend 2-3 months with me in 2011, 2012 and 2014. It is critical that u take some time, think back and pen down all the observations u saw during those visits. 2-3 months is a long period of time and it is very important that a comparison be drawn to what u saw back then to these videos.
