As u said I need to move to an apartment, and one that needs to be furnished.

I have to either own moving costs or find an apartment that is furnished till the house goes on sale.

I also have to find health insurance that covers me across the united states so that u need to spend minimal out of your pocket for my care to the best degree possible.

That said it is very important that u speak with other family members and arrange the money that will be needed.

You have to keep in mind that I live on a \$1000 spousal support, with everything stolen and a brain that is under attack every 3 min in the house. The videos that shows the attack I am under every 3 min inside of the home is being demoed in clinics along with the PI report.

It is impossible to find a job when I am under this kind of attack. I have done nothing but try to find a job since 2013. I have been deliberately kept away from finding a job so that my brain could be attacked to the degree it was since 2013 on the inside of the home.

I have 5 months of recordings to show the extent of attack I am under inside of the home which needs to be figured out. I have no resources. The money needs to be arranged by you **ESPECIALLY SINCE U CHOSE TO BE MY SUPPORT FOR YEARS IN THE SYSTEM WITHOUT PRESENTING THE OTHER SIDE OF THE STORY.**

click on messaging - you can view all the conversations with the number of people I have tried to reach out to. If I succeed in finding a job my brain cannot be attacked to the degree it is. There is no way in hell I will be able to find a job till my brain needs to be attacked the degree it is.

On your visit here, u can sit down with me and go thru every one of the videos and see the extent of attack I am under inside of the home.

if u plan a visit which is very helpful from a personal observation standpoint please make sure u own more courage to make your statements clear to the system, U had plenty of courage in 2012 to be very clear with the psychiatrist and the case workers that if there is a problem that it should be fixed. You exhibited none with regard to asking a very simple question, why does it happen only on the inside of the home? why was she stolen of everything? why is she under attack the extent she is on the inside of the home?

I hope that helps with what is needed moving forward and yes I will do my best to find a place close to eating joints and super markets AND ONE THAT IS VERY AFFORDABLE AT THE SAME TIME.

Hi Moal,

Further to our letter of 6<sup>th</sup> March, 2017 which you have not studied peacefully, we have carefully gone through the "Order for Judgement and Decree" and shocked to see the unexpected verdict and that too very fast. The order stipulates that you have to vacate the house within one month of the order, i.e. by 23<sup>rd</sup> March or so. There are number of points need clarification / challenge etc.; but a Court order is to be obeyed first, then can challenge through an Appeal Subsequently. We are not sure of the rules prevailing in USA.

Fortunately, I have just received my Visa and though we both are not comfortable for such a long travel health wise and financially, but trying for earliest flights depending tickets availability to reach there prior to the dead line. You have also forwarded the Court order to Shom / Shai and we are not sure of their reactions / decisions. Tiara's final examination and allied matters are in progress.

We discussed the matter in details by ourselves and shall let you know the travel schedule earliest. Whatever documents needed by you, under the changed circumstances shall be done by us when we are there.

It is better and right for all of us to locate a small apartment on rent, in all respects conveniently near to the shopping / eating places, enabling not to depend on transportation facility.

Regarding Shom / Shai, once again, we feel better you talk / write to them directly.
