Other Places she visits frequently since 2010 that can be validated via Credit Card Statements, Wal-Mart, Target, Pier 1 Imports, Creative Kids Stuff, Cub Foods, Indian Stores in Eden Prairie(India Spice House) and Bloomington TBS Mart, Byerlys, Whole Foods, Michaels, Party City, Fast Food Joints (Burger King, Mc Donalds, Panera, Chipotle), Restrauants (Big Bowl, P.F. Changs), Malls consistently around celebrations (Mall of America, Burnsivlle Mall, Southdale Mall), Gas Station SouthBridge Pkwy – has cameras, CAL"S Market and Bachmans each summer, Flash Portraits couple times each year, USPS Shakopee, Disney on Ice Shows – Target Center, AMC Movie Theater, Lakeshore Learning, ABC Toy Zone (Edina), Between 2010 and 2012 (Sawatdee Indian Restaurant on Sundays for the most part).

# **Other Social Interactions**

I have about 62 emails that are invites between <u>playdates and birthday party invites</u> not to mention emails that I might not have even kept track of between 2010 and 2016 averaging to <u>about 10 invites a</u> year.

I have about an additional <u>150 emails that are invites from friends in the community</u> between 2010 and 2015 averaging to about 25 -30 additional invites a year.

At these interactions with regard to the respondent, why would they not call 911 if the respondent was experiencing a psychotic attack in their presence? The community certainly did not seem to have any trouble calling me in otherwise. It just would not add up that in the light of the reports that my presence of psychosis at all the places that I have been at each day would not be reported into 911.

How are the children socially deprived ? If you analyze the petitioner's credit card statements you will also find the kids were always to off to some fun place over the weekend having fun. In what way were they deprived of any social interaction or just plain simple fun?

<u>Do I exhibit any social withdrawal</u> on grounds of the <u>evidence</u> cited or an <u>individual that has done her</u> <u>best to stay that focused</u> so she can block out everything around her and not let anything get to her?

She <u>returned to the place of work</u> that <u>she was the Director of Development</u> at right <u>after committal</u> inspite of the <u>mental health stigma</u>. <u>Did she exhibit</u> any <u>avoidance or social withdrawl</u>? It can be <u>argued</u> that <u>she</u> is unaware and <u>exhibits situation incongruent behavior</u> OR it can be seen that <u>she exhibits a very consistent pattern</u> of <u>being out there from the get go</u> i.e. since she quit a job <u>since 2010</u>.

#### **Since the Divorce Proceeding**

# U.S. Bank

- She has spent plenty of time at U.S. Bank Eden Prairie tracing accounts and trying to dredge up old credit card statements
- She has also spent plenty of time trying to ensure that copies of all pertinent documents were available at the Safety Deposit Box at U.S. Bank
- She is a very familiar face at U.S. Bank since the Divorce Proceeding
- Talk to any personnel. Was she Psychotic during any of her interactions with any personnel at the Bank and she has numerous interactions at the Bank.

#### **Scott County Courthouse**

- Since April of 2016, I have been a regular visitor to the Scott County Courthouse.
- I spend my mornings in the Court House taking in Trails and other cases to give me a sense of how lawyers fight their cases
- There is no evidence of any kind of psychosis in the courtrooms.
- I have ensured that I stayed a consistent pattern each day of spending my mornings in the courthouse.

#### **Fedex**

- I am a very frequent visitor at Fedex since the Divorce Proceeding and prior as stated further below in this document. Reasons that are not Divorce specific are stated further below.
- Since the Divorce Proceeding as indicated further below in this document given the
  extensive electronic harassment experienced, I have spent many hrs at Fedex, making
  copies, printing documents and mailing letters out.
- I am a very familiar face there.
- There are no psychotic episodes while interacting with the individuals at Fedex.

# Burger King Eden Prairie and Burnsville on 12th Ave

- I drive in each morning for breakfast and am a very familiar face at both these joints.
- There are no psychotic attacks while interacting with these individuals.

Please note the absence of any police reports since Nov 2015 is proof of the fact that she is not psychotic during her interactions. Any co-laterals collected later should be questioned as why did they not want to come forth earlier.

To summarize she is out each day for at least about 5 hours on an average, spends all day out with the kids for at least 5 weeks of the Summer in places where there are plenty children around where caregivers should be very sensitive to a psychotic person in their midst and should call in 911 if she is having a psychotic episode. She is very social (again no difference in her social interactions as her behavior) if you analyze the number of interactions that she is part of in the community not to mention the consistent patterns of celebrations that she has kept going in the household so that the kids can experience all the fun and joy in their lives, with no psychotic attacks documented as evidence, not to mention the lack of cognitive decline with her ability to stay on top of all her goals. If any observations with regard to changed behavior in social interactions were noted they were not provided as evidence.

Please also note that <u>there is no difference in behavior in terms of social</u> <u>interactions pre-2010 and post 2010</u> which <u>refutes any statements that can be</u> <u>made on the grounds of mania</u>. Please also note that <u>there is no evidence of any kind of irresponsible behavior</u> as stated above that manic individuals can experience and that this individual has not.



There will be almost as many trips to the library to finish what I am working on to save costs, as preparing the documents at Fedex in addition to printing would have cost me twice as much or thrice as much. So I would prepare the document free of cost at the Scott County Library and drive up to Fedex to print to save costs. I will have no way of proving my frequent trips to the Library as Scott County Library does not keep track of any historical information with regard to visits to the library even though it requires for me to swipe my card every time I access a terminal. You could however interview the library attendants to know if I was a frequent visitor in the library.

<u>A new Computer was purchased with pre-installed software</u> around the April – September timeframe of 2015 as the <u>old computer was constantly running very slow and was giving me licensing issues with</u>

Microsoft Office Programs. Regardless I had the same issues with the new computer as well and was forced to purchase a maintenance plan thru Best Buy in September 2015 as an attempt to get some help with the electronic harassment and as an attempt to start keeping some logs of the harassment endured. My new Computer was slowed down as well and experienced licensing issues constantly with Microsoft programs ensuring I could not edit documents, till I spend some money at FedEx, even though the computer was relatively new and I should not have experienced any issues with pre-configured software.

# Exparte served November 20th, 2015.

Same pattern continues where it is impossible to print at home and am forced to endure increased Legal Costs and immense amount of harassment at a time where printing is so necessary with the amount of paperwork that needs to be filed and a time where it is important to have costs curtailed.
